Convention bureau gets council's OK

The Ruidoso Village Council Tuesday accepted a proposal from the Ruidoso Valley Chamber of Commerce to establish a convention and visitor's bureau.

Village Councillor Ray Dean Carpenter recommended postponing discussions of the proposal since councillors hadn't had time to review it, but Councillor Rick Davis disagreed, calling on members to act on the chamber proposal.

Councillor Davis said he didn't see that it made a difference if members had reviewed the proposal or not since it was the only one received.

Ruidoso Valley Chamber of Commerce executive director John Jeffers explained Wednesday that the proposal was prepared in accordance with a request for proposals issued by the village.

Jeffers said the village request called for creating a convention and visitors bureau to perform many functions now being done by the chamber.

He said in past years lodgers' tax funds were budgeted to the chamber for postage and contractual services, and with the new bureau those funds will no longer go to the chamber.


Jeffers said the proposal, to use village economic development funds and lodgers' tax funds to promote Ruidoso, was prepared in accordance with the request for proposals.

The plan calls for hiring a director and a secretary/receptionist, and Councillor Victor Alonso asked whether two people should be hired at once and wondered if qualified applicants can be found at the proposed salary levels.

Jeffers said he already has resumes from recent graduates of several universities, and said he's sure qualified people will be found. He said the director will be traveling and generating work and will need a secretary.

Since the chamber has no secretary, and under the new plan won't be receiving the contractual services funds, Jeffers said the secretary/receptionist position is very important.

Police make drug bust

Lincoln County law enforcement agencies seized more than 12 ounces of marijuana and illegal drug equipment Monday in Capitan, according to police.

Danny Stewart, investigator for the Ruidoso Police Department, reported they "received information that Richard F. Brann was growing marijuana at his residence west of Capitan."

Acting on this information, Ruidoso and Capitan police, with the New Mexico State Police and the Sheriff's department, entered the residence, just outside the

village limits, with a search warrant issued by Magistrate Judge Gerald Dean.

Inside the residence they found two separate hydroponic greenhouses where marijuana was being grown, said police. The suspect was not there, police reported.

Brann returned briefly late in the day and was observed going in and out of the residence, said police. He was apprehended by the Roswell Police Department Monday evening and, on an order by Magistrate Judge Jim Wheeler, Brann was taken to the Ruidoso Police Department, police said.

Council nixes neon

The Ruidoso Village Council Tuesday pulled the fuse on a Planning and Zoning Commission (P&Z) decision that would have allowed a neon sign for the Cattle Baron Restaurant.

P&Z, during its last regular meeting, allowed a variance for the new restaurant to install a neon sign although neons are specifically prohibited. The action prompted appeals by a number of citizens.

In a letter to the mayor and council, village attorney John Underwood said, in part, "While I certainly understand their (P&Z) position in that the neon sign in this situation is extremely well done and tasteful, it is still my legal opinion that, based upon Ordinance 8-9-10 (k), neon signs are absolutely prohibited within the Village of Ruidoso."

Underwood called the P&Z action "improper" and said it "should be reversed."

During Tuesday's meeting Underwood said the sign ordinance has no provision for variances.

But enforcement officer Sandy Hall said the P&Z Commission has granted sign ordinance variances in the past, adding that Underwood's is the first legal opinion issued.

Underwood said the ordinance is so clear to him that since it has been brought to the attention of the council it will have to be enforced or changed.

Before councillors unanimously overturned P&Z's action, they heard from sign company owner Don Eckland who suggested the ordinance be revised to allow for "non-conforming signs."

"It's kind of ludicrous to have something say absolutely no," remarked Eckland. He said the Cattle Baron sign was "very, very tastefully done" with neon inserts. Eckland said neon signs advertising various beers can be seen in bars throughout the village.

Gail McIntosh said she isn't opposed to neon signs, but wants the village to be consistent. Appeals were filed by McIntosh, Candyce Garrett and Ted Bennett.

Councillor Victor Alonso, too, called for consistency.

"I feel a little betrayed," said Alonso, recalling past problems. He said he bought a business in 1976 that had neons, but as he remodeled he found himself fighting P&Z over signs.

"I was flatly rejected and I've

learned to live with it," remarked Alonso. "If we allow a neon that neon now is a monopoly in reverse," he added.

Later in the meeting Cattle Baron owner Jeffrey Wilson thanked the council for its decision, and said he didn't intend to be controversial.

"You just made my project come in under budget," said Wilson. He said the village needs a survey on signs and architectural conformity, and offered a \$1,000 check to help "underwrite" the cost.

Mayor Lloyd L. Davis Jr. told Wilson the current sign ordinance underwent a very long public hearing period. He complimented Wilson on improvements he's made on the Sudderth Drive building where the Cattle Baron will be located.

Also Tuesday, councillors heard Al Junge complain of "no visible action" on a guardrail he proposed seven weeks ago for a "very hazardous curve" on Warrior Drive. Junge said a ditch at the curve is full of water and he warned of possible drownings as well as injuries.

Junge talked of possible liability since the village has recognized the problem.

"I don't recall personally recognizing that it is dangerous," said Mayor Davis. "I don't think the council has admitted anything," he added.

Davis said village engineer Mike Davalos is checking on several such areas, and will report at the next meeting.

Junge said the water in the ditch could be drained, and Mayor Davis wondered if Bog Springs can be ef-

fectively drained. "If somebody drowns you've got a problem," noted Junge.

He then lambasted The Ruidoso News for an editorial on executive sessions, noting it was written by a person who doesn't come to council meetings.

"Executive sessions are a must if you're going to run a city government," said Junge. "(It) doesn't mean you're sweeping anything under the rug," he added. Junge said he didn't think the editorial was factual and said he thought it implies somebody on the council is dishonest.

Junge suggested asking the "city editor" to come before the council and explain what he meant by the "unfair" editorial. He also suggested scheduling executive sessions before other regular business so that any action taken can be announced.

Later in the meeting, Councillor Shaw, calling for an executive session to discuss litigation and personnel, said she wished she could have called for the meeting before Junge's speech.

In other regular business Tuesday, the council:

—Approved a restaurant license (beer and wine only) for Derf Dot Inc., doing business as Fred's, to be located at 2327 Sudderth Drive.

—Heard Tim Morris report on the Sierra Blanca Airport Commission.

—Adopted an ordinance changing the effective date of a municipal gross receipts tax to July 1, 1987.

—Adopted an ordinance changing

the village lodgers' tax ordinance to track with state law.

—Voted to schedule public hearings on ordinance changes effecting the Parks and Recreation Commission, the Adult Recreation Advisory Board, security alarm penalties and the one-call utility code.

—Set in motion procedures to establish special paving districts in Pinecliff, Town and Country North and other areas. Councillor Elmer Pirelli suggested that citizens interested in having their streets paved contact village hall to ask to be included.

—Adopted a 1987 holiday schedule (see related story).

—Postponed discussions on requests for proposals for legal, engineering, plumbing, electrical and professional planning services after hearing that councillors had not had the opportunity to review proposals received.

—Accepted a proposal from the Ruidoso Valley Chamber of Commerce to establish a conventions and tourism bureau. (See related story).

—Approved plans to proceed with a central warehouse project after hearing village clerk Leon Eggleston report the old shop can be remodeled, a computer added and gasoline distribution converted to a card system for \$47,116. He said 17

departments will share the cost, and Mayor Davis recommended shares be prorated according to use.

—Listened to a plea from Bill Rawlins on behalf of petitioners asking Lincoln Cablevision to keep Public Broadcasting System channels 3 and 18 on the air. Rawlins said he has a petition signed by 300 people, and Mayor Davis explained that the council has no regulatory control over cable programming.

"You can take HBO and MTV and all the immoral garbage that's on there and shove it," remarked Councillor Alonso.

"I think Paul (Crown) better listen to his customers," said Councillor Pirelli.

Mayor Davis told Rawlins the council had expressed its support of the petitioners, adding "that and 50 cents ought to buy you a cup of coffee."

—Heard Alonso report that his business for the first 20 days in January is up 34 percent over the same period last year. He said his evening business, mainly tourists, is up 51 percent for food and 16 percent beer and wine; while his lunch business, mainly locals, is up 13 percent for food and 50 percent beer and wine.

"I'm kind of concerned that our locals are depressed and drinking more," quipped Alonso.

The bureau will be housed in the chamber building, according to the proposal.

"Didn't we approve this at one time?" asked Mayor Lloyd L. Davis Jr. "Wasn't this to back up and make it legal?"

He said recommendations on contract terms can be made to Jeffers and Underwood, and the council unanimously approved the proposal.

"We will ensure that the program is successful," said Jeffers.

Included in the package are details of a marketing and promotional plan, advertising and distribution plan, operating facilities, convention solicitation and related services. A four-month budget for the rest of this fiscal year and a 12-month budget for next year also are included.

The four-month \$43,428 budget includes \$38,628 in village economic development funds and \$4,800 from the chamber. Of that total, \$13,550 is for administrative, \$25,800 for office operations and set up, \$750 for a required audit and other miscellaneous costs with \$3,528 set aside in a reserve fund.

The proposed budget for the next fiscal year is for \$163,900, with \$48,400 from economic development funds, \$2,000 from the chamber, \$112,500 from occupancy tax and \$1,000 from special events. Much of that total—\$94,700—is budgeted for advertising and promotion, with \$39,800 for administrative, \$17,900 for office operations, \$1,500 for an audit and \$10,000 for the Ruidoso brochure.

The proposal will now be detailed in a contract to be prepared by the village attorney and signed by both parties.

Election Tuesday Voters will decide school mil levy fate

Ruidoso voters will decide Tuesday, February 3, whether to continue the two mil levy for Ruidoso Schools.

According to the 1975 Public School Capital Improvements Act, the mil levy must be approved by voters every three years.

The mil levy has been used since 1981 in the Ruidoso school district for furniture, equipment, building maintenance, re-roofing, playground equipment and maintenance equipment.

Even though the two mil levy was approved by voters in the last election, the schools have been unable to collect the full two mils due to the reassessment of property values.

"The Yield Control law prohibits the collection of over a five percent increase in taxes," explained Sid Miller, Ruidoso School Superintendent. "The new assessment brought the price up so much we couldn't use it. This is a new election and new levy on the new assessment so the schools can get the full two mils."

The recent bond election monies are being used for building additions and remodeling of the Ruidoso schools, but the bond money cannot be used for equipping the added rooms or for maintenance or repairs of existing buildings, according to Miller. As an example, Miller cited the new fire code laws requiring solid doors on school rooms instead of the hollow core doors now in place.

"Because the facing on the present doors will not hold a solid door," Miller said, "it is going to cost \$1,000 a door to replace all the doors. Part of the mil levy funds will be used for that. The top priority for the funds will be re-roofing Nob Hill School."

The assessing rate for property owners for the two mil levy is 33 and one-third percent of the appraised value of property on the tax rolls. On a \$30,000 property the assessed value is \$10,000. The increased tax, for the mil levy, would be \$9.28 per year for that property.

Downs is no speed trap, trustees and police agree

Talk of traffic, tickets and speed traps highlighted a presentation of the annual Police Department report during the meeting of the Ruidoso Downs Trustees Monday night.

Trustees expressed their concern to Ruidoso Downs Police Chief G.L. "Skip" Hazel and Sergeant Jan Cary that some motorists, apparently including tourists and visitors, had complained of the Downs being a "speed trap."

But the officers rebutted the charge, noting that fewer traffic tickets were issued last year than in 1983. A colorful graph was included in the department's eight-page annual report which illustrated the fewer number of tickets last year, which averaged 165.58 tickets per month, when compared to 1983, which averaged 243.17 tickets per month, according to the report.

The five officers in the Downs in 1986 issued a total of 1,877 citations, of which 1,516 were speed offenses, according to the report.

It was pointed out that four-laned Highway 70, "a straight shot," is heavily travelled.

Trustee J.L. Wilson questioned the police on an issue he said has been brought up to him.

"I've heard that we have a quota to fill," he stated.

"There is no quota system at all," Hazel and Cary replied in unison.

Cary reported that the most cooperative motorists stopped at the Downs roadblocks are those from out-of-town. He also touched on the philosophy of conducting roadblocks.

"I figure if I have to buy insurance, and I have to have it, so do they," he noted.

"Everything is done in accordance with constitutional guidelines," he added.

Mayor J.C. "Jake" Harris invited any other police departments that choose to refer to the Downs Department's statistics in their reports could come to Ruidoso Downs and "get their facts straight." His comment apparently was a reference to the recent Ruidoso Police Department annual

report which pointed out a disparity in the number of citations issued in the two villages.

In that report, Ruidoso Police reported their 22 officers issued 1,597 citations, of which 375 were for speed violations.

Ruidoso Downs Municipal Judge Martin Valenzuela reported that his office had received "at most 20" letters complaining of traffic policies in the Downs, while letters containing compliments of the department also were received.

"Based on the figures here, we don't have a speed trap," concluded Trustee Conrad Buchanan.

Trustees then turned their attention from ticketing to sentencing, and questioned Valenzuela on the policies surrounding the community service program in the Downs.

Valenzuela explained he utilizes the service—which allows offenders to serve on community service projects in lieu of paying fines or serving time—infrequently, having assigned just eight offenders to community service work last year. He said he decides which offenders are to do community service work

in the Downs, and which are to be sent to participate in the community service program organized in Ruidoso.

Trustee Wilson, who termed the program "tremendous," asked that Valenzuela include a running tally of the hours assigned and served in each of his reports to the trustees.

In other business, the trustees:

—Heard Wilson mention an editorial in The Ruidoso News on executive sessions and advise his fellow trustees that the group should be very selective when choosing to conduct executive sessions.

"I think the editorial in the paper was well-written," commented Buchanan, who noted his feeling that the group is very watchful of following guidelines for executive sessions.

"I'll be the first one to recommend that we observe the law," added Harris.

—Approved Ordinance 87-1, increasing building permit fees.

Ski Apache readies for weekend anniversary party

What has become one of the premier resorts in the country began 25 years ago as a simple high-mountain cow pasture with a fancy name—"White Mountain Park."

The Forest Service was interested, back in the late 1950s, in finding someone to develop winter recreation in the area under a special use permit, according to information provided The News by

Tim Livingston. Robert O. Anderson, prominent businessman, turned out to be the one for the task, and White Mountain Park the site.

An intensive development program began, and by 1961, the area was ready for skiers with a few trails, three T-bar lifts and a few buildings. Possibly the most "monumental" task was constructing the road to the ski area.

From that beginning, the area

has grown into Ski Apache Resort, operated by the Mescalero Apache Tribe. Now, seven modern chair lifts and a four-passenger gondola whisk skiers to the top of a mountain full of challenging trails.

Ski Apache will celebrate its 25th anniversary Saturday, January 31, with a special race and cocktail party.

The "Oldtimers' Race" will be at 11 a.m. on the Smokey Bear

NASTAR course, with registration open until 10 a.m. All age divisions are invited to participate.

Muffin Breakfast

If your family is ready for a hearty breakfast every morning as mine is, you know how difficult it is to come up with a little variety now and then. 



Ruidoso has tied Roswell, 33-33, and defeated Goddard, 45-24, in dual-match competition this season.





Cody Willard led the Brave boys with 12 points. Guyman Kaydahzinn, Ronnie Randolph and Bill Chambers each added eight points.


Alva Blake led the girls scoring with eight points. Jennifer Parker, Joellyn Commanche and Melinda Schut each added six points.


Schmidt named wrestler of week





Chamber gets convention bureau update; joins membership in Spirit of Ruidoso

In the regular monthly meeting Wednesday, the Ruidoso Valley Chamber of Commerce Board members learned the Village of Ruidoso received the chamber's formal proposal Tuesday night for the Convention & Visitors Bureau. Board member Charlie Smith expressed his strong desire that the final contract for the bureau be specific in its expectations, so that the chamber will not be open to future "criticism or bad press." Hirschfeld said members reaffirmed the chamber's involvement in community activities, and everyone had a good time. It was suggested by Buster Hill

that there be an occasional 4 p.m. board meeting in which members would not be hurried during their workday. All agreed that such meetings would provide the opportunity for longer discussions and "brainstorming." At the retreat, according to Jeffers, there was some discussion about the Spirit of Ruidoso becoming a branch of the chamber. The Spirit steering committee recently met and decided against such a move. The decision prompted a "letter of intent" drawn up by Roy Crocker regarding the matter. The Spirit voted to become a member of the Chamber of Commerce and asked that the chamber become a member of the Spirit of Ruidoso. In a general discussion, board members expressed their strong support of the Spirit and voted to become a member of that organization. Also during the meeting, board members: —Welcomed new member Rick Davis, who replaces Kerry Boyd on

the board. —Heard an advertising update by Robert Boverie. —Learned from Jeffers that there are five new chamber members: A Good Place to Eat, Villa Inn, Ruidoso Inn, B&B Feed & Farm Supplies and Ruidoso Taxi/Scenic Tours. Ruidoso Lodgers and the Printing Press were reinstated. —Heard a update on President's Club activities by Buster Hill. —Learned from Hill that two of the cleanup campaign signs have been completed. —Learned that the new village maps are not yet complete due to the many changes and corrections, which should be finished soon. —Approved chamber support of the "Right to Work" legislation, which provides that no employee should be forced to join or pay compulsory dues to a union. —Barbara DiPaolo updated preliminary activities on the Art Festival.

Spectacular sky stunts are Franklin's bread and butter

Jim Franklin can safely be called a high roller.

Franklin, perhaps the top aerobatic and stunt pilot in the United States, spends at least half the year soaring, gliding, tumbling and rolling in airshows from Florida to California and from Texas to Canada.

But when it's time to relax, the Lovington native heads for the mountains of Ruidoso where he and his wife, Audeane, have chosen to make their headquarters and home.

At the end of the 1986 season Franklin brought home an airshow industry trophy that has been compared with the movie industry's Academy Award.

The International Council of Air Shows, during its 18th annual convention last December in Las Vegas, Nevada, presented Franklin with the Art Scholl Memorial Award for Showmanship. As the first winner of the award, Franklin's name will be the first to be engraved on a permanent plaque to be housed in the Experimental Aircraft Association Museum in Oshkosh, Wisconsin.

Franklin's own plaque hangs, along with his other awards and aeronautical memorabilia, in the Ruidoso condominium the Franklins will call home until they build a house on their Fort Stanton Road property near the Sierra Blanca Regional Airport site.

"The new airport is one reason we decided to move up here," said Franklin, adding he had heard of plans for the airport for years but began to believe a couple of years ago that it is really going to happen.

Franklin has flown in and out of airports all over the United States and Canada, but made his first "official solo" out of the Ruidoso airport.

"So this airport is not new to me," noted Franklin. He admits it's a tough airport.

And with a hectic schedule like Franklin's, he said he needs to fly in and out at night and in all kinds of weather—things that just aren't possible at the current air facility.

By the time Franklin made his official solo while working with Ralph

Brown at the Ruidoso airfield where he spent several boyhood summers, he had logged a great number of flying hours on his family's Lovington-area ranch.

"I flew my first solo when I was 12," recalled Franklin with a smile. He said he ended up alone on the ranch and decided to take the family airplane up for a spin.

Lots of people might have been upset to come home and discover their 12-year-old had been out flying, but not in the Franklin family.

"You'd have to know my dad, he thrives on that kind of thing," said Franklin. Within a few months of that first flight, young Franklin was given the job of flying a plane out over the range to feed cattle from a special hopper installed under the small airplane.

"From the time I can remember I was sitting in an airplane holding the controls," said Franklin; whose rancher father also runs the Lovington airport.

When the 13-year-old pilot saw his first airshow in Hobbs, he knew where he was headed, and it didn't take him long to get there. He flew in his first airshow when he was just 19, and has remained in the business for the past 20 years.

"Airshows have gotten to be big business—it's not barnstorming anymore," said Franklin.

Perhaps one reason for Franklin's showmanship award is his airshow presentation in which he portrays "Zar, exiled knight to the benevolent monarch Kin Zon ... the greatest starship captain of the Universe" and pilots the starship Pride.

The tall slender Franklin, as Zar, wears a specially designed black costume and flies a Ted Smith Aerostar, painted black with silver trim. Zar puts starship Pride through gyrations and stunts that particularly surprise those familiar with the Aerostar executive plane.

"The kids really love it," said Franklin, who sees airshows as a growing entertainment medium.

His act continues as he pilots his Waco Mystery Ship, a biplane that has been completely redesigned and rebuilt. Wingwalker Johnny Kazian joins Franklin standing on a wing while the plane loops, rolls and flies upside down.

Next season, which begins for Franklin on March 15 in Lakeland, Florida, will feature a brand new specially designed plane and a duel act that will include some breathtaking midair dog fights and interlocking loops, said Franklin.

"I'm kind of known for coming up with things that are new and exotic," he admitted.

Between airshows, Franklin has performed aeronautical stunts in several movies, including "The Three Amigos," starring Steve Martin and Chevy Chase.

Franklin also performed in "Choke Canyon," a movie with lots of stuntwork.

Franklin says the stunts he performs are not as dangerous as they look, and states unequivocally that he feels no fear when flying.

"It's as dangerous as you want to make it," said Franklin. He says he makes sure that all his equipment is in tiptop shape and knows just what its and his limits are. Franklin boasts that in 20 years he has had no serious accidents.

Apparently that's not counting the time he had to bail out of a friend's plane when it came apart in the air.

Franklin said as an adventurous 20-year-old he would fly anything, and went up in a plane he knew little about. Luckily, he was wearing a parachute that day, although he didn't always wear one.

When he pulled the cord on the chute, it was his 34th jump—the first 33 were just practice.

On March 31, 1968, as a result of having his life spared because of an emergency parachute jump, Franklin became a member of the Caterpillar Club.

"If you ever do something that scares you, that means you're exceeding your abilities," noted Franklin, looking back on his close call as the nearest he's been to being scared over his 20-year career.


For now, Franklin is looking forward to taking possession of his new airplane and hitting the clouds for the 1987 season.





Inside the Capitol

SANTA FE—One of the least amusing aspects of the "war" that started this year's legislative session in our state Senate was the animosity in some of the losers in that engagement showed toward the members of our Supreme Court.

Mounting signs, with the name of each of the members of the court on them, including his or her political affiliation, on the chairs behind the Lieutenant Governor's podium in the Senate chamber was not as laughable as those who carried it out might have wished.

It is worth observing that it would be unwise of those who showed themselves poor losers in this fashion to attempt any kind of recrimination against the judiciary when the budgets for that branch of government are being considered.

Another small remark about those unpleasant hours with which the session began has to do with lack of courage of some of the lobbyists who frequent each legislative gathering. Some of those people made a great effort to stay away from the Roundhouse entirely until it was clear which of the two contending sides would triumph.

After all, these brave souls wouldn't want to be seen talking to the wrong people, lest that might lead to punishment from the other side if it turned out to come out on top.

And speaking of punishment, how about this one?

After that battle between the two evenly balanced groups in the Senate had been resolved, the winners of-

ferred a special opportunity to the losers concerning the membership of the Rules Committee.

That particular group has more than ordinary importance to the man who sits in the governor's chair, since it has to review and approve of many of the people he appoints to high office. If it wants to, the committee can cause the chief executive great pains.

That being so, the Democrats who won the battle offered the Republicans more than half the seats on that body so that it would be clear the Demos didn't intend to punish the governor for what the other side has just put them through.

The Republican leadership, however, refused the sixth seat that arrangement would have given them, and insisted on balancing the membership at five Republicans and five Democrats, making tie votes possible if ever the voting is along party lines.

When asked why they chose that, one of those involved said, "This way we can see that things are tied up evenly, and let the other guys take the blame for punishing Governor Carruthers."

It's that kind of almost purely negative thinking that makes some of those who failed to win the big battle of 1987 hard to get along with.

Every year when the State Police start asking for a raise in their budget, listeners remember the days when we only needed two cops to guard the whole Legislature.

We used to have one uniformed officer in the gallery on the House side and another in the gallery on the

Senate side. They seemed completely competent to keep order in both bodies, without large numbers of reinforcements also working the building.

Nowadays, though, you see uniformed and armed officers all over the building, so many of them, in fact, that one wonders who's out doing the policing of our highways and byways while a legislative session goes on.

One man who came out of all this fighting in the Senate in the early

days of the year looking good is George Foster Hannett.

He argued the case of those Senators who claimed it was illegal for the Lieutenant Governor to break a tie in matters of organizing the Senate and that it was not constitutional to have a double-headed leadership in their body. Though there were four good lawyers on the other side, including three members of the Senate itself, Hannett's arguments prevailed.

He deserves some applause for his conduct of the matter.

There were times, as a single parent, that I didn't think my son, Eric, and I would make it.

With each new day, it seemed, came a new challenge. I often questioned my strength, my parenting ability and sometimes, even my sanity. His 16th year was the worst. I gave everything I could, but somehow it just didn't seem to be enough. His mood swings were extreme and he often complained of boredom.

The more loving and understanding I was, the more he seemed to take advantage. Sometimes, he would simply patronize me. Finally in desperation, after a particularly trying evening when Eric became verbally abusive his first and only time, I took an extremely strong stand.

I felt the full impact of my mother's words, "This hurts me more than it hurts you," as I faced my rebellious son.

Quietly but forcefully I expressed my anger and frustration at his refusal to allow me to show my love without his taking advantage. I said that he would no longer be allowed to switch from child to adult as his mood and situation dictated. He would now be treated only as an adult, and as an adult would earn every penny given him from that

moment on. I told him his duties, explaining that they would be monitored on a daily basis. A poor job would receive no pay.

I explained that from the money he earned, he would be required to provide his own food (at home and at school) transportation and clothing. I acknowledged his superior intelligence and strength and challenged him to prove it. I made it very clear that I would no longer tolerate his laziness and impudence, stating that the next time he was verbally abusive, he would find himself in Juvenile Hall.

When the rules were clearly defined, I asked if he had any questions or comments.

"I guess I have no choice," he replied.

"Yes you do," I answered, "You're welcome to use my phone to make other arrangements, and there's the door. The streets are full of kids who don't care."

For about an hour after our conversation, Eric slammed things around in his room. As his chores neared completion, he came into my room. "This is a blast!" he said enthusiastically. "When do we go shopping?"

That was the beginning of our friendship.

Jockey David Lidberg brought home an impressive five winners last weekend at Sunland Park Racetrack to take the Jockey-of-the-Week honors, while trainer Cliff Lambert Sr. saddled four winners over the same period to take the honors in the training department.

Salustio Burgos remained atop Sunland's rider standings with 38 winners, after making just one trip to the winner's circle during the weekend. Danny Sorenson and Pedro Benitez closed to within a single win of the top spot with two winners over the weekend's action, while Joe Martinez passed Mike Lidberg to take over fourth place with 33 tallies. Lidberg has won 32 races thus far this season.

After a season-long battle in the trainer standings, Doyal Roberts Sr. has finally caught Fred Danley to take a piece of the top spot. Both conditioners own 25 wins for the season. winning margin to a length. The final time was 1:12 1/4. Guy Bowers of Ruidoso earned \$1,700 for the effort. Lewis Germany trains the 4-year-old gelding.

Trainer Stewart Welch conditions Will Cut, who finished a length in front of Mr. Nicholas. Joe Martinez rode Will Cut. Cliff Lambert Sr. trains Mr. Nicholas, who was ridden by David Lidberg.

Farmer Brown opened his 4-year-old campaign earlier this month going wire-to-wire over allowance rivals at 6 1/2 furlongs. He earned nearly \$12,000 last year finishing in-the-money for 10 of his 21 appearances.

Sunland Park resumes racing next weekend with programs scheduled Friday, Saturday and

Sunday starting at 1 p.m. each day. Saturday and Sunday the track will host "The Best Of The West Handicappers Showdown" with a guaranteed \$2,500 jackpot. Entrants will bet a mythical \$1,000 bankroll on 22 races over the two days. The handicapper with the largest amount of money at the end of the contest is the winner.

Sunland Park will be hosting its "Best Of The West Handicappers Showdown" on Jan. 31 and Feb. 1. For a \$25 entry fee, participants in the contest must handicap every race over the two-day period, with no exotic wagering. Each person will be given a mythical \$1,000 bankroll and the contestant with the most money in his bankroll at the end of the two days is the winner. First prize is at least \$1,500 and the winner will represent Sunland Park in the World Series of Handicapping at Penn National Race Course in Pennsylvania this fall. First prize in that \$187,000 event is a hundred-grand.

Prince Ego, last summer's Norgor Futurity runner-up, turned in a solid performance in his 1987 opener. The well-bred son of Bold Ego was wide in the final turn but had the race well in hand (or hoof) throughout.

Sunland's Twin Trifecta pool is on the rise again. The Friday, Jan. 30, Twin Tri will have a carryover of more than \$11,000.

Ruidoso Downs leading rider Joe Martinez also had a three winner

day last weekend. The talented thoroughbred rider won with Alariva (5-2), Pass Em Up Kid (2-1) and Take No Prisoners (8-1) during last Sunday's program.

Jockey David Lidberg took jockey of the week honors in his final weekend of racing at Sunland during the spring meeting. The 22-year-old reinsman recorded five victories over the weekend's action and currently holds down sixth position in the rider standings with 23 tallies. David will now head to Albuquerque for its opening next weekend. Trainer Doyal Roberts finally collared season long leader Fred Danley in the training department. Both conditioners have made 25 trips to the winner's circle this season.

Sunland Park will start a series of simulcasts next weekend when the \$100,000 San Pasqual is presented from Santa Anita on Sunday. Precisionist took the grade I event in 1985. The \$500,000 Strub from Santa Anita and Hialeah's \$200,000 Widener are also on Sunland's calendar.

Restless Charger dodges the pack Saturday

El Pasoan Glen Murphy rode Restless Charger to a decisive upset over Riley Allison Futurity winner Senator Billy B. in Saturday's headliner at Sunland Park Racetrack.

Heading postward as the overwhelming 2-5 favorite of 2,760 fans, Senator Billy B. set all of the early fractions in Saturday's 5-furlong allowance test before being run down in deep stretch by Restless Charger.

Murphy held Restless Charger

off a fairly slow pace through the backstretch before moving on the leaders as the field rounded the bend. The young rider caught Senator Billy B. at the eighth pole and drew away in the final furlong to win by a length in 1:00 4/10.

Dr. Farley, a 7-1 shot ridden by Joe Martinez, nosed Senator Billy B. out at the wire for second-place money.

Restless Charger was let loose at

more than 11-1 odds for his first start in nearly four months. Trainer Doyal Roberts saddled the winner for Edwin and Maurine Boyd, who earned \$1,680.

Dr. Farley was another first-time starter at Sunland. Anita Morse owns and trains the Oklahoma-bred. Kenny Lewis rode Senator Billy B., who is conditioned by Paul Smith. Senator Billy B. gained national recognition in 1985 when he captured the \$340,000 Riley Allison Futurity at Sunland Park.

Prince Ego reigns the reins in Friday race

Prince Ego, a royally bred son of 1981 Preakness runner-up Bold Ego, appears to be on track for a solid shot at this year's Riley Allison Derby following his strong performance in Friday's feature race at Sunland Park Racetrack.

Trainer Cliff Lambert Sr. sent the 3-year-old colt out for his first official appearance since finishing a distant third in the \$155,000 Norgor Futurity last June at Ruidoso Downs.

Despite the long layoff, four bullet workouts over the local oval prompted Sunland fans to back Prince Ego down to the odds-on

choice for Friday's 6-furlong allowance test. Reb's Battle, at 5-1, was the closest contender on the board after Hiesa Trusty Native was withdrawn from the race.

Jockey David Lidberg piloted Prince Ego from the rail post, taking command of the sprint midway through the turn. At the quarter pole he held a two-length advantage and managed to fight off a surprising bid from 35-1 outsider Lone Star Ranger to win by a length in 1:13 3/10.

The effort earned \$1,500 for owners G.G. Staley and G.C. Huckabay, who have nominated the Texas-bred for the upcoming Riley

Allison Derby - a mile-long event scheduled April 19.

Lone Star Ranger checked in more than three lengths ahead of third-place finisher Reb's Battle. Lone Star Ranger, who was ridden by leading jockey Salustio Burgos, is trained and owned by Matt Mattox. Roy Marcom saddled Reb's Battle with Mike Clark at the reins.

Bold Ego, who stands at Aire Alto Stud Farm in Clovis, drew attention last year as a freshman sire when his first crop produced 1986 Riley Allison Futurity winner Big Bold Boz.



Sunland's mutuel island opens

Sunland Park opened its new pari-mutuel betting island to Clubhouse patrons Friday, allowing construction to start on a 2,100-square-foot lounge that will feature a floor-to-ceiling fireplace and big-screen sports

monitors. The mutuel line and lounge are part of \$500,000 in renovations to Sunland Park's Clubhouse that were begun shortly after United Tote took over operation of the track last November.

Heavy handles prompt bigger purses

The new owners of Sunland Park Racetrack announced Friday that the track will increase its daily purse distribution beginning Friday.

President Lloyd Shelhamer said the boost was justified by a significant increase in both handle and attendance at Sunland Park during the past month.

"With the recent changes in our wagering format, a half-million

dollars in renovations and an aggressive marketing plan, we're experiencing a renewed interest in horse racing that has pushed our figures considerably over last year's totals," Shelhamer said. "We based our purse structure on the previous season and are happy to be able offer this incentive for the horsemen."

Despite a freak snowstorm that forced cancellation of Sunland's rac-

ing program last Saturday, the track's daily attendance over the weekend was up 34 percent, while the average daily handle jumped more than 50 percent.

Last Sunday, the track experienced the fifth highest handle in 28 years of operation when 4,464 fans bet \$507,749.

The most recent purse increase follows a similar announcement last month when Sunland officials

boosted purses an average 20 percent for upper-grade races.

Friday's announced increase is "distributed on a scale for horses running \$4,000 and higher claiming races, with the biggest increase visible in the top allowance class," Shelhamer said. Purses for those races will increase from \$3,000 to \$3,500, he said.

Racehorse breeder is named for honor

The Mesilla Valley's burgeoning community of horse breeders gained statewide recognition recently when Canutillo rancher James Hambrick was honored by the Texas Thoroughbred Breeder's Association.

Hambrick's homebred racehorse Lubbock County was voted the top 2-year-old thoroughbred filly for 1986 after earning more than \$50,000 her first year on the track.

"Every time I think about it, I kind of choke up," Hambrick said of the award. "It's a great feeling to see one of your own that you've bred perform like Lubbock County has done. It's difficult to express the feeling that you have."

Lubbock County's heritage traces back three generations to a mare that was given to Hambrick while he was working for El Paso Natural Gas Co. in the early 70s. After breeding stock for more than a decade, he retired from the gas company four years ago to start a new career training race horses.

Hambrick now devotes all of his time to conditioning a successful racing stable that campaigns at Sunland Park, Ruidoso Downs, the New Mexico State Fair and the Downs at Albuquerque.

"My wife, Ellen, and I own our entire stable," Hambrick said. "We have 11 horses on the track, six mares at home and five yearlings that will start racing next year."

One of the Hambrick's most suc-

cessful pupils is Flemish Slipper - a 5-year-old thoroughbred who has earned \$91,000. He was voted New Mexico's top sprinter last year by the New Mexico Horsemen's Association.

Lubbock County drew attention to Hambrick's training abilities after winning last year's Kachina Stakes at Ruidoso Downs, where she also finished second in the Pocket Coin Handicap.

"I picked up what I know about training from various trainers, primarily Whitey Nolen, who trained for me for a number of years," Hambrick said.

Both of the Texan's star performers are sired by Jeremi Johnson, who used to stand in Berino, New Mexico.

"It was more or less an accident that I ran across him," Hambrick recalled. "But after I saw him and looked at his pedigree, I decided to breed to him."

Hambrick is sold on the stud's abilities. Over the past several years, he has trailed four mares nearly 300 miles to Slaton, Texas, to breed with Jeremi Johnson. Seven horses in his racing stable are sired by the stallion. Three of his five yearlings also are products of Jeremi Johnson.

"He's had phenomenal success with a number of mares," Hambrick said. "I don't remember seeing one of his offspring that couldn't do some running."
