Council sets hearing on golf course

A multi-million dollar proposal to place a championship golf course and resort hotel on the old Ruidoso Municipal Airport land got mixed reviews Tuesday.

Developers, during an afternoon workshop and also during the regular council meeting, described to the Ruidoso Village Council plans to develop the golf course and a 200-room hotel under a low-cost lease agreement on the municipal land, and councillors set a public hearing to take action on the proposal. "I kind of feel like the guy that finally got a date to the prom," said Ruidoso Mayor Lloyd L. Davis Jr. "I can't believe they want to do this," he added, before introducing representatives from Jim Colbert Golf, SWD Motels and Lamb Architects.

Councillors and close to 100 people who gathered in village hall, got a look at conceptual plans and heard details of a preliminary agreement hammered out with village attorney John Underwood and the prospective developers.

The 18-hole, par 72 golf course described by Jeff Brauer of Golfscapes, will be 6,850 yards long. Brauer said the Scottish-style course will make the best use of the environment and available water, noting he considered aesthetics,

playability and maintenance in his design.

"We're very sensitive to the environment," said Brauer, who has been questioned at various times about the impact to the environment of the plan. Both Brauer and Jim Colbert of Colbert Golf stressed that chemicals used on the golf course will have no effect on the surrounding area.

"We feel this is a complete facility with sufficient quality to attract

people to Ruidoso," Brauer said.

Bill Davies, CEO of SWD Motels, said his company already has invested \$30,000 in the project, but stressed the importance of having both the golf course and the hotel.

"Without the golf course, I'm going home," Davies said.

Although the initial lease doesn't include big dollars to the village, developers used figures to show the

economic impact of just having the hotel achieve 55 percent occupancy. At that rate, according to presenters, the village will take in about a quarter of a million dollars in gross receipts and lodgers taxes.

Former village councillor Victor Alonso questioned the 55 percent occupancy target, wondering if any Ruidoso lodgers hit that figure now.

R.D. Hubbard, the Texas millionaire who now owns Ruidoso Downs Race Track said financial institutions won't be lending \$6.5 million on what's been done in the past.

"If I'd have gone by what's been done in the past at the racetrack, I wouldn't be here," said Hubbard, who is the driving force behind the current proposals.

Colbert, a professional golfer as well as a golf course developer, said during a previous meeting that he wouldn't even consider the Ruidoso development if it weren't for Hubbard.

Members of the audience wanted to know more about water and chemicals, Ruidoso resident Charlie Gray predicting the drainage lakes on the golf course would dry up Cedar Creek. Councillor Larry Simon tried to explain the relationship between that creek and the water table, but Gray continued

Golf course/hotel plans are described

Ruidoso councillors will decide June 19 on a multi-million dollar development that will include a championship golf course, a 200-room resort hotel and a community/events center.

Close to 100 people gathered Tuesday for a presentation on the more than \$6 million plan that developers propose to finance and construct on the 160-acre site that once was the Ruidoso Municipal Airport.

Councillors listened to the lengthy proposal, viewed the architectural concept plans and set a public hearing for 6:30 p.m. Monday, June 19, to act on an ordinance on the lease agreement to develop the hotel and golf course on the municipal land. During that hearing, the village council will consider terms of a lease agreement with Colbert Golf, Inc. and SWD Motels, Inc.

Firefighters battle blaze

Area firefighters stayed busy Tuesday with two separate fires.

At 2:54 p.m., the fire department received a call about a grass fire behind a cabin at 165 Juniper Road. Eighteen firemen responded to the call along with three forestry units. The thick smoke from the fire could be seen from a distance. In all the fire burned about a half acre behind the cabin.

Fire Chief Virgil Reynolds said the fire was apparently caused by some coals which were dumped behind the cabin.

At 7:20 p.m., the fire department responded to a cabin fire behind the Hollywood 7-11. Two employees of

the nearby Dairy Queen, Bernadette Castillo and Donna Garcia, saw the fire through the window and called the fire department.

When units of the Ruidoso Fire Department and Forestry Service arrived the cabin and several nearby trees were totally engulfed in flames.

Firefighters had the blaze out in about 45 minutes and forest service personnel eventually cut down one of the tree because it was so badly burned.

Chief Reynolds said he still didn't have any idea what started the fire because no utilities were hooked up and the cabin was unoccupied.

Landfill set to open.....really!

Trash trucks may roll to the Fort Stanton landfill as soon as next Monday.

The Lincoln County Commission, in a special meeting Wednesday, took action to re-open a small portion of the landfill by Monday, June 5, through a contract with Ruidoso which guarantees the village \$8,000.

The new site would be available to contractors and those commercial entities that gather household garbage, such as Ruidoso Downs, Carrizozo, Alto Village, Sun Valley and Alpine Village.

The joint powers agreement hammered out Wednesday morning and approved by commissioners, states that a one-and-a-half acre site will be re-opened on county land adjacent to the old landfill, and will be jointly operated by the

George Puckett, executive director of the Economic Development Corporation of Lincoln County, announced that his organization, after running an advertisement, received close to 100 inquiries and is negotiating with 30 prospects interested in bringing industry to the village.

Puckett said the airport land is the only suitable site for industry. He said one group interested in developing the land could be the next Disney land.

"They want to use the entire site as a theme park and hire 4,000 people," said Puckett.

Although the Sierra Blanca Regional Airport master plan includes an industrial complex, Puckett said that's too far from the village for the industrial users who have indicated an interest in Ruidoso.

Frank Kolb, chairman of the board charged with overseeing development of the airport land, was surprised by Puckett's announcement. He said his group has had no inquiries from any group other than the golf/hotel developers.

Councillors will act on the proposal during the June 19 hearing, just one day before voters will decide upon a proposal to change the form of government in Ruidoso from mayor/council to commission/manager.


In other regular business Tuesday, the council:

—Adopted a resolution making changes to village personnel regulations.

—Opted out of the 911 program after learning that Contel doesn't have the equipment to provide that service in Ruidoso.

—Gave final approval to the wastewater treatment drying beds construction project, budgeted for \$398,266.14 and completed for \$399,127.31 with a \$275,000 Community Development Block Grant and village match.

—Heard Councillor Al Junge turned down on a request to be added to the agenda. Mayor Davis said councillors asked him not to allow last minute additions, and Junge said he would remain after the meeting was adjourned since some members of the audience wanted to hear what he had to say.

Downs makes deal on dump

State officials have come to an agreement with Ruidoso Downs Mayor Jake Harris over the disposal of village garbage.

Ruidoso Downs has been dumping garbage on private land with the consent of the landowner. However, EID considered the action illegal.

Carl Stubbs, of the Environmental Improvement Division, said Harris has agreed to stop disposing of Ruidoso Downs trash on private land, and will remove the garbage for proper disposal.

According to Stubbs, Harris was meeting with an EID employee Wednesday in Hondo during the time Lincoln County Commissioners were meeting in Ruidoso.

Harris has given a verbal agreement to have made proper arrangements to have Ruidoso Downs' garbage properly disposed by June 10, said Stubbs. That date coincides with the new county landfill being available for commercial use.

At this time, EID is not planning any legal action against Ruidoso Downs, said Stubbs.

Village attorney John Underwood, who has hammered out a preliminary agreement with the developers, said the village will provide the land and allow the developer the right to use 200 acre feet of effluent credit water rights. Those rights are the 50 percent bonus the village receives for Rio Ruidoso water that is used and returned through the village wastewater treatment plant into the system.

Jeff Brauer, of Golfscapes, Inc. of Arlington, Texas, told the crowded council chamber, the proposed golf course will be a Scottish style championship course, adding that design will reduce the total of maintained turf and the amount of water needed by the course. He also said part of the terrain lends itself to the Scottish style.

Brauer said the golf course, which is being designed by professional golfer Jim Colbert, will feature double greens, mounds and grass bunkers in the tradition of Scottish golf courses. He said the course will have multiple tees for all levels of golfers and will play to a par of 72.

The golf course will have 12 acres of water for irrigation, drainage and to provide fill dirt for the mounds. The concrete material from the old runways will be buried under the mounds according to Brauer.

Golfer Jim Colbert, who was present for the meeting, said the fairways will be lower than the surrounding mounds to allow the golfer to be somewhat protected from the wind. He said the layout of the course is still conceptual and may change a little bit. Colbert said he is considering having the longer holes on the course play with the prevailing winds instead of against them.

"No one likes to play a hole into the wind," Colbert said.

Brauer said the ultimate objective of the golf course is to be a destination for tourists.

"We feel this is a complete facility with sufficient quality to attract people to Ruidoso," Brauer said.

That's why the golf course and

hotel developers told councillors their deal is interdependent.

Gary Lamb, of Lamb Architects of Tempe Arizona, described plans by SWD Motels, Inc. to develop a 200-room hotel with an indoor-outdoor swimming pool, a fitness center, a 2,000 square foot meeting room, a lounge, pro shop and restaurants.

Lamb said the hotel will be designed in a Southwestern style with a mission look of massive wall and a smooth stucco exterior, and will include 40 percent suites. An additional space for 40 more rooms has been put into the original design.

Adjacent to the hotel and connected by a walkway will be the village's proposed 12,000 civic and activity center. The activity center will feature a small kitchen area and a large outdoor patio.

According to preliminary agreements, the village will be responsible for booking the activity center, but the hotel will be able to lease the center from the village for hotel functions.

Bill Davies, C.E.O. of SWD Motels, Inc. said his company is in discussion with two major groups to franchise the hotel. Davies said to franchise the hotel will cost 10 percent of the gross, but the benefit of a franchised hotel is the nationwide reservation system it would have. However, he said if no franchise is found, SWD Motels will be the owner and operator.

Davies said SWD Motels, which is based in South Dakota with an office in Tempe, already spent \$30,000 on the proposed hotel project. He said he believes the combination of a resort hotel and golf course will work in Ruidoso, but he is not going to commit to a large hotel without the golf course.

"Without the golf course, I'm going home," Davies said.

He said his company will hire local subcontractors to do a lot of the work, adding the hotel will employ about 75 people during the peak seasons and around 20 in the off season. Pay will run from \$5 to \$15 dollars and hour for most jobs.

Davies went on to praise Ruidoso and the area around the village.

'California here I come,' sings Cooke

After six years in Ruidoso, and three years in Capitan, music instructor Churchill Cooke feels it is time for him to follow a different drummer.

"I need to go where I can grow some more," he said on his departure from Ruidoso schools.

Besides, "the two most important women in my life are in California."

When he's finished the school year in Ruidoso, Cooke will be moving to the vicinity of Visalia, California, to join his wife and daughter.

His years in Lincoln County have been very enjoyable, he said. The kids have been great and tremendously talented in both Ruidoso and Capitan.

A 1973 graduate of Penn State, Cooke has been teaching voice in New Mexico for 16 years. There was a brief respite teaching in Florida for one year, "but became homesick for New Mexico," he said.

"Teaching kids how to sing is the greatest thing in the world," said Cooke. By moving to another school system, he hopes to reach as many children as possible during his career.

The curriculum Cooke has established in Ruidoso is based on his philosophy there are 100 songs that every American needs to know.

Many people feel they are incapable of singing, especially among Anglos, but with proper training and encouragement, anyone can learn to sing, he said.

Cooke has very much enjoyed working with the elementary students, for this is the age when children are still receptive to singing as an enjoyable pastime, he said.

He also said he hopes the school system finds a replacement willing to spend the time at the elementary schools, rather than delegating voice lessons to the teachers there.

When you have a college educated person teaching voice, even in the elementary schools. Not all elementary school teachers are qualified to teach voice," he said.

The reason many people grow up thinking they cannot sing, said Cooke, is they received poor training at the start.

The spring musicals each year have been the most enjoyable portion of his career, said Cooke.

"I appreciate a lot of the people in this town," said Cooke about the support he's received from the community.

Cooke also hopes this will develop into an all-around award for students that recognizes exemplary achievement in the arts, athletics, and academics.

"Arts are a basic," also, said Cooke and should be stressed along with other activities because they enhance the development of a well-rounded individual.

Cooke acknowledges California

will be different and he will miss simple things like cool mountain air, and not having to lock his car all the time. Still, he looks forward to the new challenges and opportunities in his new home.

county and the Village of Ruidoso. The Ruidoso Village Council, in an emergency meeting Wednesday afternoon, also approved the agreement.

The county will provide one bulldozer to help with the initial digging of the pit, an operator for the bulldozer and someone to operate the gate.

Ruidoso will provide at the cost of \$8,000 a bulldozer and operator to dig the pit and to cover the pit.

The agreement will run until September 6, 1989. County officials emphasize this agreement is only to provide temporary relief during the summer months. A long term solution is still being sought.

Elected officials and other officials representing various municipal and private groups were invited to attend the meeting. Jess Stinson, of the Ruidoso Village Council was present, as well as Infrastructure Division director Becky Bell-Durham, village manager Frank Potter, village attorney John Underwood and division director Leon Eggleston.

Carl Stubbs of the Environmental Improvement Division (EID) was present, and representing the county were attorney J. Robert Beauvais, county manager Nick Pappas, commissioners Robert E. Hemphill, Karon Z. Petty and Rick

Simpson and county clerk Martha McKnight Proctor.

No one was present to represent Ruidoso Downs, Alto Village, or other unincorporated areas in the county.

Both county and village officials said each of their own sanitation needs were presently under control. The purpose of the meeting was to see if something could be done to help local contractors and municipalities, such as Ruidoso Downs, who at present have no place to legally dispose of their waste.

Ruidoso is sending its garbage, after compaction, to Roswell, and will continue to do so, said Bell-Durham. The county takes its garbage to the landfill at the Fort Stanton Hospital and Training School.

Elsewhere in the county, the Village of Capitan has applied for a permit for its own landfill which, if used to meet local needs, has an expected lifetime of eight to 10 years, said Beauvais.

However, those areas that are in most need of a dump site had no representation at the meeting.

"I am very disturbed (Jake Harris) is not here because he's hollered the loudest," said Beauvais.

The county attorney reported that Ruidoso Downs is currently dumping garbage on private land.

Beauvais said the action "is illegal as far as the EID is concerned," despite the fact Ruidoso Downs has the permission of the landowner.

"Ruidoso Downs should be willing to pay to dump their trash if Ruidoso and the county are willing to put up the other costs," said Stinson.

When Leonard Corona said it will take two weeks to dig a pit for the new dump site, contractors expressed concern over the delay.

A compromise was then worked out in which contractors will be allowed to dispose of heavy lumber and other items that will not blow away.

As the pit is dug, these items will be pushed into the trench.

The landfill will operate Mondays, Wednesdays and Saturdays from 8 a.m. to 5 p.m., but trash would not be accepted after 4 p.m.

A county employee will be deputized to monitor the garbage entering the site and collect fees. That person will have the authority to issue citations.

Officials urge individuals hauling trash to cover their loads to avoid being cited for trash blowing off and littering the roadways.

The fee schedule adopted by the county is as follows: for private contractors, and individuals hauling yard trash, pine needles or slash will, \$3 for a pick-up load or trailer

load up to eight linear feet; if the length of the load is greater than eight feet, but less than 12, the fee will be \$6; from 12 to 16 feet, the fee will be \$10; loads longer than 16 feet will be \$10 for the first 16 feet, then \$1 per foot afterwards.

For example, a load of pine needles in a pick-up truck with a bed six feet in length, and a trailer ten feet in length, would be subject to a \$10 charge.

For commercial haulers of trash, the charge will be \$4 per yard, the total cost based on the total capacity of the vehicle. For example, if the village of Ruidoso Downs arrives at the site with a 25 yard capacity truck, the charge will be \$100 whether the truck is full or not.

Commercial entities which use pickup trucks or flat beds will have the total capacity of the vehicles established with the county prior to use.

Any other commercial generator of trash, such as campgrounds or other recreation sites, should contact the county manager's office in Carrizozo.

Agreements with municipalities will have to be signed if a monthly billing procedure is desired. Otherwise, each load will have a fee assessed at it reaches the site, county officials said.

for maintenance and golf course storage.

Some of the terms of the proposed hotel lease with SWD Motels, Inc. are:

—The term of the lease will be 50 years.

—Under the terms of the lease, for years one to five, SWD agrees to pay the village a minimum of \$2,000 per year. At such a time during this period, the hotel occupancy rate reaches a percentage of 65 percent annualized, then the village will receive two percent of the gross room revenue.

—From six to 10 years in the lease period, SWD will pay the village two percent of the gross room revenue so long as SWD has 55 percent room occupancy annualized.

—From 11 to 30 years of the lease term, SWD agrees to pay the village three percent of the gross room revenue as long as SWD has 55 percent room occupancy annualized. The amount paid to the village goes up to four percent, during years 31 through 50 of the lease, with the same percentage of room

occupancy.

—All of the above are subject to SWD having 55 percent room occupancy annualized, otherwise SWD is only liable for the minimum rate of \$2,000 per year.

—Excluded from the gross room sales will be such items as all restaurant charges, uncollected credit and installment balances, all excise and sales taxes required by law, all vending, telephone, utility sales and service.

—The village agrees to construct an activity center simultaneously with the resort hotel if sufficient funds are available.

—The lease with SWD is contingent upon the village entering into a lease with Colbert Golf.

—The village is to provide adequate water, sewer and public street access directly to the hotel from State Highway 43.

—The village agrees, for the purpose of SWD's obtaining the necessary funds for construction of buildings and improvements, to subordinate SWD's interest to the first mortgage of the property, if the

subordination is allowed by the State Department of Finance and/or the State Board of Finance. The village will cooperate with SWD in helping to find other funding sources should such subordination fail. The village will not become personally liable for the payment of any such mortgage and SWD shall save and hold the village harmless from such liability.

—The village is responsible for all site clearing and grubbing to make the site ready for construction. The village is responsible for payment of real estate property taxes for the land and responsible for all other taxes.

—The village will waive all city, plan check, building and development fees.

If the village enters into the lease with the two companies, construction would begin as soon as possible and Colbert Golf should complete the golf course by the end of 1990.

All the terms of the lease agreements will be up for discussion during the June 19 public hearing.

Red Cross Chapter organizes here

Through flood, famine and fire, the Red Cross is an organization that is always on the front lines of any disaster.

But as with any volunteer organization, more hands are needed and if enough can be found, Lincoln County will have its own Red Cross chapter, said volunteer Rebecca E. Wardlaw.

Currently, Lincoln County depends on the Red Cross chapter in Lea County, known as a lead chapter, to cover any disasters which may occur in Lincoln County.

New Mexico does have a statewide organization, Wardlaw said, but a list of volunteers here in Lincoln County and specifically, Ruidoso, is definitely needed.

"Lea County has got volunteers to cover this area in case something

happens," she said, "but what is needed here is a basis of volunteers."

She added that the Red Cross does offer classes in CPR and First Aid, but the group tries not to compete with other organizations such as the American Heart Association.

"The primary services offered by the Red Cross are in disaster relief," Wardlaw said.

These services include coordinating disaster plans, such as evacuation in case of fires and floods. The responsibilities of the Red Cross also include developing disaster plans, running evacuation shelters and working with insurance companies in evaluating damage in the aftermath of a disaster.

In addition to providing financial relief to large-scale disaster vic-

tims, Wardlaw said the Red Cross also provides financial relief in single-residence fires for families with no insurance.

Red Cross employs only a handful of paid staff and therefore relies almost completely on volunteers. Wardlaw said the success of this type of organization depends on a roster of people who have specialized abilities to contribute.

"The Red Cross needs people with special skills who are willing to get on a list," she said. "They put together a network of volunteers with special resources."

She added that volunteers are trained in special classes on the different areas of disaster relief, which helps form a network of different forms of expertise.

The Red Cross will have a meet-

ing at 7 p.m. June 16, at the Texas-New Mexico Power Company to generate interest in forming an organization to handle disasters in Lincoln County.

Forest fires are definitely a concern in this area, Wardlaw said, and a more local organization would definitely be to the advantage of the Ruidoso area.

"The city isn't totally equipped to help with that," she said. "They could have a problem there."

She added that the community gets back what it puts into the organization.

"People don't like to get involved, but when something happens people say, 'Where's the Red Cross?'" Wardlaw said. "The question is, who would they be expecting to help them?"

Ben Konis is a serious artist. But, painting is not a job to Konis, it is something he enjoys and has fun doing.

That same fun and enjoyment he gets from painting is what Konis tries to teach his art students.

This past week Konis was busy teaching a class at the Carrizo Art School in Ruidoso. Konis has taught art classes throughout the country and abroad, but every year, for the last 19, he returns to teach a class in Ruidoso.

"This at one time was the only art school in the Southwest," said Konis. "I like Ruidoso, the cool nights and the warm days."

Konis is active in his art class, going from one student to another, talking, critiquing and encouraging.

He says every class he teaches is different because of the different personalities and seriousness of each student. Yet, he approaches each class the same.

"We are all students, all our lives," Konis said. "Most painters don't have patience. You have to teach patience and discipline, they go hand in hand."

He said he has to tailor his instruction according to the experience level of his students.

"At times I am a little kinder to the beginner and tougher on the professional," he said.

Many of Konis' students have taken his class before. Some take his class year after year.

"I don't know why they come back," he said, "but they do."

One of the reasons could be because of his teaching methods. Konis uses sound instruction, productive work and a lively sense of humor in teaching his students.

"I think you've got to have fun doing it," he said. "It is not a job. It's kind of crazy being an artist, you can't take it too seriously."

Konis uses photographs and live models as subjects for his students to paint. Konis has taken photographs all over the world with his old Nikon camera and says he wants his students to see in their paintings what he sees in the camera.

"I teach them to see what the camera does," he said. "I want them to interpret it into a painting. And sometimes the painting is more interesting than the photograph."

Konis will be presenting three more one-week workshops at Carrizo Art School this year: July 24-28, July 31-August 4 and October 9-13.

Fire danger 'explosive' in Lincoln Forest

With dry conditions and no rain in sight, the United States Forest Service has bolstered its Lincoln National Forest staff and equipment with some help from California.

Five model 60 fire engines were brought in from the San Bernardino, California, district of the United States Forest Service to assist local forest service staff during the current extreme dry conditions, according to Steve Makowski, fire management officer for the Smokey Bear District.

Each unit has five crew members and will remain in the area for at least 10 days.

Makowski said it was a 24-hour straight drive for the crew from California to Lincoln County.

Two of the units and crews are housed in Ruidoso, two in Cloudcroft and the fifth unit has been stationed in the Carlsbad area.

The units each have a 500-gallon water capacity.

The additional equipment and staff was moved into the Lincoln National Forest with fire conditions

reported as the most volatile in at least 15 years. Also on standby are two Mescalero fire fighting crews and a Bureau of Land Management DC-7 air tanker.

Expected high winds and dryness have placed the forest in the worst fire conditions since 1974 when the Spring Fire consumed more than 15,000 acres.

Logging and road-building operations were shut down Tuesday when the fire danger was described as "explosive." Forest service staff said logging operations won't

resume until the dry forest gets some rain.

Precautions implemented throughout the forest include strict bans on open fires and smoking in forested areas.

Over the Memorial Day weekend forest officers issued nine citations for campfire violations.

Special Olympics are great, says team sponsor of 20 years

Mary Lee Daniel is dedicated to Special Olympics.

She has been involved in working with Special Olympic youth for 20 years. The last several years she has been the coach, fund-raiser, driver and friend to the kids involved in the Special Olympics program in Capitan.

Daniel, who lives in Ruidoso and is a teacher at Capitan Elementary, said she currently has six kids in the program. Four of her kids will be going to the New Mexico Special Olympics Summer Games on June 9 at Albuquerque's Milne Stadium. Next year, she said she hopes to have eight to 10 students in the program.

She said participation in the program depends on volunteers.

Special Olympics takes a lot of time according to Daniel. She said there are never enough volunteers and chaperones, but the rewards are great for those who work with the kids.

"It is so rewarding to go to the events and see how the kids enjoy it," Daniel said.

She said the Olympians began preparing for the Summer Games in the early spring with some general running and exercise. The kids themselves choose the events they want to participate in. Once they do this, Daniel helps them concentrate on the specific skills they need for the event.

Daniel said this year she won't get to go with her kids to the Summer Games, because she will be out of town. The Capitan kids will be going with the Alamogordo delegation. Alamogordo and Capitan are part of area 12 Special Olympics, which also includes Fort Stanton, the only other school in Lincoln County with a Special Olympics program.

She said the trip to Albuquerque is being funded by \$1,000 which was given to the area by the state Special Olympic organization. The T-shirts and the trip to the zoo, Daniel said are paid for out of money raised locally.

Of the four local kids going to the Summer Games in Albuquerque, Daniel said Anthony McEuen will be the only one from this area involved in the mile run. He will also participate in the 400-meter run. The three girls who are going to Albuquerque, Serena Stockton, Jennifer Wheeler and Janell Stockton, will all be participating in the running long jump.

Jennifer Wheeler, who is in her first year of Special Olympics, will also participate in the 100-meter run. Janell and Serena Stockton are in their second year of Special Olympics and will be participating in the 400- and 800-meter runs respectively.

Daniel said the time of the year the Summer Games takes place is hard on the kids, but it is harder for them not to go and participate

because of the training they go through.

Daniel says sometimes the long hours she puts in working with the Special Olympics kids tires her out and she wonders if she will do it next year.

"Sometimes you think about not doing it," she said, "until the kids ask when does Special Olympics start. How can I say no, it is a part of me."

In other Special Olympics news, local organizer Lou Wardwell of the Ruidoso Police Department said a very special auction is scheduled for 9:30 a.m. Saturday, June 3, at the Elks Lodge on Highway 70.

The auction of locally donated items will benefit the New Mexico Special Olympics program. Among the items to be auctioned are belt buckles, jewelry, southwestern arts and crafts, collectibles, gourmet candy and cookies, Indian and sheepskin rugs, skis and a stereo cassette player.

Wardwell says there are many other items as well.

Also both local Pizza Huts are participating in Special Olympics fund-raising said Wardwell. On Friday, June 2, Pizza Huts will donate to Special Olympics \$1 for every medium and/or large pizza sold.

Special Olympics' activities will culminate in the Special Olympics Torch Run by area law enforcement officers on June 5.

Homeless critters find haven

It's a haven for the lost and afraid, the cold and abandoned, the hungry and homeless. Those who end up there don't receive hot soup and a change of clothing; instead, they get dog chow, fresh water and distemper vaccinations.

Director Randy Basch said the Humane Society of Lincoln County located in Ruidoso offers more than just food to lost and abandoned animals. The Humane Society has become a temporary home for those awaiting new owners.

Strays can be a problem in any community, and Basch takes the job of finding good homes for the animals very seriously. The problem of animal over-population stirs to life the controversy of euthanasia of some of the animals that are brought to the shelter.

"People will condemn us for euthanizing and I won't justify killing a healthy animal," he said. "But I think that humane euthanasia is preferable to an irresponsible home."

The fee charged for the adoption of an animal not only goes toward the funding of the shelter, but also ensures that the owner will have a financial investment in the animal, Basch said.

"Consequently, we get fewer adoptions, but our primary concern is for the animals," he said.

Basch added that the contract signed by each person who adopts an animal requires that an adult animal be spayed or neutered within 60 days and puppies and

kittens within six months of age or a \$150 penalty will be assessed against the owner.

An unspayed female dog can be responsible for more than 10,000 descendants in a 10-year period, Basch said, and the number of cats is significantly higher. Although it is difficult to cite an exact number, Basch said he has to put about 30 animals a month to sleep.

"Most of those are puppies and kittens from people with unwanted litters," he said. "Some people think that they don't contribute to the problem because they give away a litter, but according to a report from the humane society, one out of 10 of those can't be accounted for the next year."

Anyone who has a litter of animals, whether they give them away or not, is directly responsible for the pet over-population problem. For every pet that is given away by someone, that is one less home for one at the shelter, he added.

"Even breeders contribute to the problem," Basch said. "One out of four of the dogs brought to a shelter is registered."

Basch added that those who have adopted animals have been very responsive to getting the animals spayed or neutered.

In addition to making sure that the animals won't reproduce and consequently add to the problem, Basch said the animals go only to places where he is sure the animal will be happy.

"We adopt animals for companionship only. Our contract forbids chaining and the owner has to have a fenced yard," Basch said. "I want to feel confident that when the animal leaves, it has a good home."

Basch added that although the shelter is funded entirely through donations, the Ruidoso community has been very supportive.

"I've rarely ever talked to any business or organization that wasn't willing to help," he said.

The shelter is for the animals' benefit only, he added, and no one is reaping any financial benefits from the shelter. Basch received just a little over \$4,000 in total income last year, but he said he's in it because he wants to see the animals find homes.

"It's rewarding when I can fit the animal with just the right owner," Basch said. "It's worthwhile for me when I see an animal that came in with a broken spirit stand up and wag its tail when I come in."

American flags were placed upon


the veterans' graves in the cemetery by the more than fifty people who attended.

Seay said the Eagles were coached by Jeff Dixon, a professional soccer player. Dixon lives in Roswell, drives to Hondo to coach the team, then drives to Ruidoso to play. Dixon also coaches a team in Roswell.

Seay said Hondo dominated that age bracket until near the end of the season when the other teams began to raise their level of play simply from being exposed to Hondo's great play. Seay said it was exciting to see how evenly matched the teams became at season's end.

Robert Donaldson's team, the Blast, finished second to Hondo in the finals.

Seay said Hondo has a future soccer star in Robert Herrera.

The 10-year-old division was also won by a Hondo team coached by Frank and Donna Sisneros.

That Hondo team faced Jace's

Seay said 100 players were in the eight-year-old bracket division.



Memorial Day races draw record crowds

Attendance and handle figures for Memorial Day weekend 1989 were up drastically at Ruidoso Downs in comparison to 1988.

Attendance was up 30.4 percent over the weekend. A total of 21,581 attended the four-day weekend. They wagered \$1,996,706.

In 1988, that figure was 16,545. The handle was also up over 1988's figure of \$1,728,140. For the season, the average attendance is 3,992 compared to 1988's 3,498. The figure is 14.1 percent better than 1988.

The 1989 average handle is \$367,529 compared to 1988 \$355,303, that is a three percent improvement over 1988. There is a twin-trifecta carryover of \$39,988.50 for Friday's races.

Straight Reality won Monday's \$12,775 Memorial Day Handicap. The colt got up in the last jump to win by a nose. He paid \$19.00, 9.60, 4.80 under jockey Mike Lidberg. It was Lidberg's second win of the

day. Fly Dragoness was second and paid \$13.20 and 6.60. Suzy Sundance, who was coupled with Fly Dragoness, was third and dead-headed with


Everoneknowsmyname, 2.40. Lidberg has been aboard for all five of Straight Reality's 1989. This was his second stakes of the year.

The Plant Corner by Sally Black



DEAR SALLY:

My office has some very nice windows that I feel will be good for some plants, but I desperately need advice on which plants might be happy here. Mario keeps bringing me plants from his home so that I may "save their lives," but I must admit that they are a little bedraggled.

Would you please stop in soon to give us a helping hand?

DEAR MARTHA:

I apologize for taking so long to answer. I take the letters as they come into to me.

After my visit to your office I have been very anxious to help you with your plant program. The windows are perfect for plants and will accommodate the very large, impressive plants.

A most important requirement of any display of plants is that it should be seen and your windows offer a prominent position; plants are too beautiful to be hidden away in a dark corner.

Plan to move your plants about, the setting should not be too permanent, as seeing the same plants month after month looking exactly the same may be dull for some.

The first rule when acquiring office plants is to choose mature plants growing in about five-gallon pots for your windows. These will settle down in the new environment much better than young plants in small pots. Don't try to re-pot the large potted plants—just place the nursery pot inside the decorative pot you select.

You should always take the particular environment into account when choosing plants and this is particularly true for windows. Before choosing plants for each window, consider how much sunshine or daylight the situation receives and how high the temperature will rise in full sun. The ideal window site is one receiving some sunshine for part of each day.

Ideally, office plants need much the same conditions as other indoor plants: reasonable light, fresh air (but not drafts), steady warmth and

careful attention in respect to watering. Unfortunately, the conditions in many work places are often not as ideal as your windows.

Excessive heat from central heating, combined with dry air and tobacco smoke can be very harmful. Check the location of heat outlets and place your plants on random height pedestals off the floor, so the plants will not have to contend with

drugs from coffee cups and other types of drinks and trash of all kinds.

I would love to see you get a large Ficus Lyrata (the fiddle-leaf fig), a Norfolk pine, a schefflera, and Ficus Benjamina and you already have a lovely rubber tree plant. This would be a great start for you to make an exquisite window dressing for all who visit our county clerk's office.

I have written columns on all the above named plants and will be happy to send you copies that you may have the care instructions for each plant.

And doesn't it warm your heart the way our governor ignored the desires of 85 percent of New Mexicans surveyed and killed the state lottery bill?

In high school civics class years ago, I was taught that under our form of government, elected officials represented the desires of the people who elected them. Either something has changed or my teachers were liars of the first order! Under some other democratic systems, a referendum can be held to determine public confidence in the government, and if that confidence is lacking, the government changes. Although not expressed exactly that way under New Mexico law, that is essentially the difference between the mayor/council/manager and the

commission/manager forms of local government. The commission/manager form is more immediately answerable to the electorate, by way of a referendum or recall, than is the mayor/council/manager form. Being more immediately answerable just might tend to make them more representative of majority opinion. One can only hope. Too bad we don't have the same choice about the form of our state and national governments. I suspect quite a few faces would change each year.

After June 20, we will have the government we deserve, by choice, apathy or ignorance. Historically, apathy usually wins our local elections.

On The Record...

The most surprising thing to happen at the meeting Tuesday of the Ruidoso Village Council, was an announcement by the executive director of the Economic Development Corporation of Lincoln County that the group has received many inquiries from businesses interested in opening manufacturing firms or the like here in Ruidoso.

George Puckett, EDCLC exec, said manufacturers and even a "Disneyland" type organization are interested in using all the old airport land. He indicated that's the only appropriate land for those uses.

"A bird in the hand is worth one in the bush," added Puckett, who had just listened to a serious proposal to develop a championship golf course and a 200-room resort

hotel on the old airport land.

So, why did George get up to say he would have been all for the hotel/golf course had it not been for all this sudden interest in the old airport land?

I had to wonder.

EDCLC, funded in part through a mill levy implemented last year by the Lincoln County Commission, is currently looking for funds to continue the business of promoting economic development in Lincoln County. The County Commission may or may not continue the funding.

EDCLC is looking for some big successes to bolster its request for continuing funding.

All those inquiries may be just the ticket.

While the EDCLC is out there

promoting the area for industries of all kinds, the Municipal Airport Planning Board is working to implement the master plan for the old airport land. When I heard about all the inquiries, I figured the airport board must be pretty excited about all this interest.

Up to now, the golf course, hotel and civic center proposals were about the only ones on the table. And now, apparently, we have some choices, I thought.

A call to Frank Kolb, chairman of the airport land planning board, didn't reveal much about all those plans.

"We haven't heard anything from anybody," said Kolb, apparently as perplexed as I was about the brand new information. Kolb, noting that his group is specifically charged with overseeing that airport land, wondered why the interest in the land hadn't been presented to his group.

As a matter of fact, there has been so little interest in the land (other than the golf course/hotel/civic center proposal) that the airport land planning

board has canceled the last few meetings.

Puckett said Tuesday the "Disneyland" group would employ as many as 4,000 people, with the other proposals for small industries using small tracts and employing a few people each. He stressed that the airport land is the only place for such industries.

Tim Morris, Director of the Transportation and Aviation Division for the village, disagreed. Morris said the Sierra Blanca Regional Airport master plan includes an industrial park. Morris said he would be very interested in hearing from businesses interested in locating in this area.

Puckett said the regional airport is located too far out for his inquiries, and complained that the Village of Ruidoso has too little property zoned for industrial uses.

Meanwhile, it was back to the proposal at hand, with some very good questions raised over the terms of the lease, the return to the village and the impact on the surrounding environment, particularly the water table.

Last Friday, a significant event happened in the lives of the young kids in this village.

LINKING THE SUN TO CATARACTS
A great many people frequently bask in the sun's rays for prolonged periods "because it makes them feel healthy." The medical community has been accumulating evidence which suggests that repeated exposure to sunlight may be anything but healthy. According to a study by researchers at Johns Hopkins University's Wilmer Eye Institute in Baltimore, there is conclusive evidence that strong sunlight leads to cataract formation. (A cataract is the clouding of the eye's normally transparent lens). This conclusion, as reported in the "New England Journal of Medicine," is based on an examination of 838 fishermen in the area of Chesapeake Bay. Researchers found that, over the years, those who wore sunglasses and wide-brimmed hats while working developed far fewer cataracts than those who took no protective measures.
