## Apache maidens come of age

The first of three Coming of Age ceremonies this summer will start today, ushering five Mescalero Apache girls into puberty.

Each four-day celebration of womanhood honors Apache maidens who have come of age in the past year, with food, dance and rituals.

Participating this year will be: — Elizabeth Begaye, a 6th grader at Mescalero Elementary, who will be in the first tepee. The daughter of Sharon and Kenneth Begaye, Elizabeth is the granddaughter of Sharon Starr of Mescalero and Raymond C. Starr of Oklahoma, and the great-granddaughter of the late Nora Fatty and William Comanche, a medicine man.

— Starlen Bigrope, 13, who will be in the second tepee. She is the daughter of Peggy Vigil and Arlen Bigrope.

— Shirley Peña, 12, who will be in the third tepee. The daughter of Seferino and Novaline Peña of Mescalero, she is the maternal great-granddaughter of Evelyn Martine and the late Phillip Martine, and the late Kenneth and the late Fannie Shosh-Chee of Mescalero and Blackwater, Ariz.

Her grandfather, Nathaniel Chee Sr., will honor her with a performance by the Mountain Gods dance group. Her sponsor for the four-day feast will be Joey Padilla and Fleta Padilla.

— Charmain Mary Naiche, 13, who will be in the fourth tepee. A seventh grader at Tularosa Middle School, she has her future mapped out in the Air Force and then college. She enjoys basketball, volleyball and outdoor activities.

Her grandmother, Mary Naiche, will stage the feast for her.

— Noreen Germaine Kazhe, 12, who is in the sixth grade at Mescalero Elementary. She will be in the fifth tepee.

Her ambition is to become an engineer. He parents are Norman Kazhe and the late Denise Kazhe. Her grandmother Mary Naiche will handle the feast for her.

### The celebration

Traditionally starting at dawn on the first day in June, July and August, the Coming of Age ceremony draws family members and friends to Mescalero to help the young women mark their passage.

On the south side of the feast grounds, a tepee is put up for each of the maidens. Next to each tepee, a long arbor of oak brush is built, where the families of the maiden will cook food to serve friends after the ceremony.

Construction is handled by the men of the families, who will go into the forest the day before the ceremony to cut trees for the ceremonial tepees. Medicine men bless the trees as they are cut and continue chanting while the tepees are assembled.

According to a description of the proceedings provided by the Mescalero Cultural Center, the first four poles, about 25-30 feet in length with evergreen branches left at the top, symbolize the four corners of the world. They are slanted inward until they touch to form a pyramid, then lashed to the central pole and firmly tied.

A young man climbs top of one pole and wraps canvas around the tepee top, while others lay oak brush against the walls and set young trees at each side of the

tepee entrance.

A pit is dug in the center for a fire that will be started later in the day. Mothers and godmothers of the maidens come from the arbor and place canvasses and blankets and buckskins on the ground in front of the entrance.

The maidens then leave their tents through the arbors and kneel on the buckskins in front of a medicine man, with the mothers and godmothers at their sides.

The girls are dressed in traditional clothing, buckskin moccasins and leggings. Sometimes, the girls and their mothers or sisters make the garments, but more often, they are borrowed from other families whose daughters have already taken part in the puberty rites.

As the girls kneel, the godmothers reach into a sack of pollen gathered from water plants, lift a

girls from head to toe, praying that they may always have strong bodies, arms and legs.

A medicine basket containing eagle feathers, gramma grass, pollen, red and white clay and other important symbols is placed in front of each of the tepees.

At a signal, the maidens run toward the baskets, around them and back to their places in front of the tepee. The baskets are moved to the east and again the girls run and circle them. After repeating that in four different locations, the maidens pick up the buckskins where they have been kneeling. They shake the buckskins toward the sun, which according to tradition drives away evil spirits that may be near and frightens off the supernatural bearers of illness.

Baskets of fruit, candies and other good treats are scattered for the crowd to pick up. Tribal members and friends stop in the arbors to breakfast on beef and Indian bread, corn, beans, potatoes and coffee.

After the morning ceremony, the maidens visit the crowd.

For the next three days, the celebration continues and the families play host to visitors with daily feasts. Dances are performed.

On the fourth day, when the last blessing is given, eight of the tepee poles are brought down.

The girls and their attendants again stand in line facing the east in front of the four remaining poles at each tepee. Four more times, they run toward the medicine baskets. But on the last run, instead of returning as before, each girl grabs a feather from the basket and sprints westward off the grounds.

The last four poles are pulled down. More baskets of candy, fruit and tobacco are scattered among the crowd while another breakfast waits in the arbors.

Although the ceremony has ended for spectators, the girls must follow a strict regime, wear their buckskin and avoid water for at least four days after the four-day ceremony.

## County seeks to halt small subdivisions

County officials hope the state will impose a year-long moratorium on subdividing land into four lots or less.

The New Mexico State Legislature earlier this year closed a loophole by passing a bill that will prohibit the breaking of lots into four without having to comply with subdivision rules. However, legislators pushed the effective date back until July 1996.

Commissioners had asked members of the county Planning and Zoning Commission to review the law and come back with a recommendation on whether to enact a local moratorium. But zoning board members said they needed more information.

County Attorney Alan Morel told commissioners the same thing Friday. He would have to research the issue more before he could recommend a course of action, Morel said. "I need to know the number of lot splits in the last month, the last six months to see if it is a problem," he said.

County Manager Carolin Cooney said commissioners are worried that landowners will rush to subdivide during the state's interim pe-

riod. Six such land divisions have occurred in the last few years, she said.

While the law requires heavily populated counties such as Bernalillo, Santa Fe and Doña Ana to adopt regulations by July 1996, other counties can wait until July 1, 1997, Cooney said.

"It's left up to us if we want to do it earlier," between July 1996 and 1997, Cooney said.

County planner Patsy Sanchez, who originally asked commissioners to pass a local moratorium, now is only requesting that a resolution be sent to the New Mexico Association of Counties, Cooney said.

The resolution, approved in a 4-1 vote by commissioners, asks the association to recommend to the legislature that a statewide moratorium be put in place.

"I believe it would have to be county by county, because not everyone could prove the need for a moratorium," Morel said.

Commissioner Wilton Howell, who voted against the motion, said he didn't favor passing an ordinance that is stricter than state law.

"I can't support it if (zoning members) can't," he said. "I need more information."

## Sheriff apologizes, gets drug unit money

Seeing his narcotics investigation unit in jeopardy, Sheriff James McSwane publicly apologized to Lincoln County Commissioners Friday for any remarks "that reflected poorly on the commission as a whole."

The apology appeared to be part of the price tag for commission approval of a grant to finance McSwane's beleaguered narcotics enforcement unit.

Commissioners had voted against matching money for the

narcotics investigation grant during previous budget sessions. They said they were not convinced the unit was effective, and were concerned about financial accountability, county liability and a possible obligation to keep the narcotics officer on staff after grant money runs out.

McSwane offered concessions to eliminate the budget-related problems. He agreed that the narcotics task force officer will be a contractual employee, who could be

## Two die in accidents on Highway 70 Wednesday

Two people died on Highway 70 in Lincoln County yesterday, in two separate accidents.

A Hondo woman was killed about 20 miles east of Ruidoso when the car she was driving veered into the on-coming lane of traffic. A Tucson woman died the same day after her car veered off Highway 70 West in Ruidoso and smashed into a utility pole.

Five people have died this year on the stretch of Highway 70 from Alamogordo to Roswell. In the record year of 1992, nine people died between Ruidoso and Roswell.

Yolanda Baca, 50, of Hondo, died at the accident scene near mileage marker 284 at about 7 p.m.


Henry Christenot, 60, of Roswell, who was driving a 1988 tractor trailer, swerved right to try to avoid hitting the car, but Baca's vehicle struck the left front portion of the trailer. Her car went under

the trailer and she was thrown into her windshield, according to a report filed by State Police Officer Robert Eshom.

Christenot was treated for minor cuts and bruises at the Lincoln County Medical Center and released. Eshom wrote that no liquor was involved in the accident and seat belts were not in use.

Rosalie Francis Blue, 65, of Tucson, died from massive internal injuries about 3 p.m. in the other accident.

Blue had been traveling all day after leaving Tucson at 7:30 a.m., police said. She was behind the car of two friends who had just stopped to talk to her about five minutes earlier. The couple told police that Blue, who had recently learned she had cancer, had been suffering from insomnia for a week, so the accident may have been due to fatigue. The weather was clear and warm yesterday.

## Resident surprises burglar

Nina Stratton was turning the corner into her Agua Fria subdivision home Saturday when she noticed the automatic garage door was closing.

It didn't take her long to realize that someone had broken into her home and had begun stashing articles by the garage door that he planned to take later.

"I had just run down to the library to return some books and to go the post office," Stratton said. "I might have been gone an hour."

"I had an automatic garage door opener and I guess that's what alerted him. I saw him going up the

stairs. I had a phone in the garage and called for help."

Her quick thinking and good timing allowed her to hang on to a video camera and some jewelry the would-be thief had placed in a pillow case.

When two Lincoln County sheriff's deputies and their backup responded, they searched the house and discovered the burglar had left by a window.

"I thought he was still here. As it turned out, he had gone through a glass window and screen and escaped," Stratton said.

"Now that I've gotten over the shakes, it makes me very angry that someone came in and messed

with my personal things," she said. "I had my nine-year-old grandson with me and he's not over it yet. I don't know that I am yet either. The first thing he did when they let us back into the house was to go pack his clothes. He was going home. He wasn't going to stay here."

The would-be thief entered the house by forcing the garage door.

"You know, you think you're safe," Stratton said. "It has a key and I assumed it was safe."

The deputies who worked the case could not be reached. Information from the sheriff's dispatch shows the call came in about 2:22 p.m.

## Ruidoso council delays downtown construction

The Ruidoso Village Council voted Tuesday to suspend downtown pedestrian crosswalk construction until the fall, instead of starting this week as planned.

Councilors and village staff expressed concerns about the effect the highway construction would have on tourism during the height of the summer season.

Assistant Village Manager Alan Briley asked the council to consider dropping the crosswalk construction, but councilors stopped short of doing that.

Briley recommended deleting the crosswalks from the contract after several downtown merchants complained the work would hurt their businesses. A handful of the 53 merchants in the three-block affected area also questioned why the crosswalks were necessary, Briley said.

Audience member Chay Rennick argued the state-funded "MainStreet" project should not be shortchanged now, especially after the village weathered many obstacles to see it reach completion.

"I think we should stay with the original plan," he said, adding the work that has been finished is an asset to the community.

Village officials hoped the crosswalks would be installed before

Memorial Day, but were delayed after the contractor had several change orders.

The crosswalks across Highway 48 (Sudderth Drive) are part of the finishing touches of a state-funded MainStreet project to improve the appearance of the downtown area. The crosswalks will be made of stamped concrete instead of bricks as originally planned, for easier maintenance.

The decision to delay the work requires state approval since the various improvements downtown are partially funded with state money.

If the delay is granted, the work will proceed "at the most convenient time in the fall," the councilors said.

The state and contractor's comments will be reviewed by the council at its June 13 meeting. Depending on their agreements, councilors will establish a date to start the crosswalk road work.

Meanwhile, the contractor is being instructed to commence work on other remaining portions of the project: bathrooms and road striping, tree replacement and installation of grates over tree roots.

Councilors agreed with Briley to delete a thin pave job on the highway running through downtown, planned as a way to cover up old striping.

Work on the bathrooms, which are planned on a city easement across from Eagle Drive, will not block traffic. Briley said the work would probably start in two weeks after the contractor, C&S Construction, gains design and permit approvals. The work is expected to take approximately 45 days, Briley said, with the completion goal set for early July.

The MainStreet project has undergone two lengthy suspensions, Briley noted. Starting in November of 1993, the sidewalk and road refurbishment was planned as a six-month project. Due to unforeseeable delays, it has stretched into nearly two years.

"It's getting to be more and more of a paper nightmare working with two-year-old monies," Briley said.

The unexpended funds granted through the state and federal government amount to \$359,263, with \$143,263 for the crosswalk and road striping work.

The village should finish the job this year and not bank on the state reallocating funds in 1996, considering the state's current economic climate, village attorney John Underwood warned. Ruidoso could very well lose access to the severance tax bond money (which expires in December 1995) if it is not expended this year, he said.

## Village moves closer to August election on fields, infrastructure

After weeks of number crunching, Village of Ruidoso councilors approved next year's \$17.5 preliminary budget Tuesday.

The fiscal package has a \$5.2 million general fund, and provides for eight new full-time employees and 17 new vehicles.

The final 1995-96 budget document will be voted on at the council's July 11 meeting.

The budget document underwent minor fund adjustments prior to the council's unanimous vote.

Changes included \$57,000 in general fund revenues for senior center handicapped bathrooms, and \$107,320 in state grant money for kitchen work at the center.

Councilors also authorized a \$6.55 million bond resolution be prepared for their June 13 meeting. The issuance of bonds is proposed for ballfields and utility infrastructure improvements (sewer and water line repairs plus water plant and building expansions).

Since several other debts will be paid off in the next few years, the

proposed new debt would not increase the village's property tax rate, Jackson explained.

If the council signs the bond resolution, an election will be scheduled for August.

In accordance with the council's vote, a financial adviser and bond counselor will be hired to study how the new debt should be structured.

Also at Tuesday's meeting, councilors rescheduled the review of a Convention and Visitor's Bureau contract until June 13, on the recommendation of the village attorney.

## Trucker seriously burned in wreck

An El Paso man received serious burns Sunday when the freight truck he was driving overturned and burst into flames on State Highway 54 near the settlement of Oscura.

Ruben Bencomo, 29, was listed in serious, but stable condition

Wednesday.

Bencomo was northbound on the highway when his 1993 Freight Liner truck left the road. He apparently over-corrected and the vehicle overturned, according to a report filed by investigating State Police Officers Mike Howard and Charles

Devine.

The accident occurred about 4:17 p.m. in Lincoln County. Bencomo was hauling a load of refried beans. No more details were available, because Bencomo was unable to communicate, a department spokesman said.

terminated at will and would accrue no county benefits such as vacation time. One deputy from his 15-member deputized staff (includ-

ing McSwane, undersheriff Bob Miller, 12 deputies and an animal control officer) also would be assigned to the unit.

The apology came at the end of a special 1.5 hour meeting called as a last attempt by McSwane to convince commissioners to accept up to \$70,000 in grant money for the anti-drug program.

Commission Chairman Monroy Montes brought up McSwane's past remarks.

"I think some statements have been made that I think need to be put to rest tonight or (they will) fester," Montes said.

"I retract and apologize to the commission as a whole for things directed to individuals that reflected poorly on the commission as a whole. If it takes an apology or retraction, I'm big enough to do that," McSwane said.

"So you no longer believe that any of us voted against it to protect (friends involved in drug cases)?" Commissioner Wilton Howell asked.

"I don't believe I directly related (commission opposition) to commissioners wanting to protect drug dealers," McSwane said. "I was relieved when I heard that the budget was your only problem."

Commissioner Bill Schwettmann offered a motion to approve the grant application and one more year of the narcotics enforcement unit. Commissioner Stirling Spencer seconded the motion.

But Montes didn't let McSwane off the hook. He said he wanted it clear that any legal fees incurred by

the sheriff when he consulted a private attorney about the narcotics unit issue would not be paid by the county. McSwane could have asked the county attorney for advice, Montes said.

McSwane said he sought independent counsel because asking for advice on how to combat the commission might have presented a conflict of interest for County Attorney Alan Morel.

Montes wouldn't budge and Schwettmann added an amendment to his motion that the county would not be responsible for any payment to a private attorney.

Montes told the sheriff to tighten up his management style and the commission would do the same. "This is not as a result of threats of litigation by the sheriff," Montes said. "I think the county would be poorly served if he did sue and it cost us money to defend our position."

The grant was approved in a 3-2 vote with Commissioners Howell and L. Ray Nunley voting nay.

"My objection is strictly budgetary, nothing personal," Nunley said, restating his opposition to the sheriff's department adding a the narcotics person to the staff when the grant money runs out.

Howell said the county is at risk of being sued in connection with drug investigations and none of the changes proposed minimizes that risk. He contended the sheriff's department already is overstaffed for the number of people living in unincorporated portions of the county.

## MADD students produce films about drinking and driving

Knocking softly at the door, the police officer knows what to expect: reactions of shock, tears, anger and sorrow when family members are told about the death of a loved one because of drinking and driving.

Unfortunately, the scene is repeated many times every day across our nation. But students at Ruidoso Middle School, in conjunction with the local chapter of Mothers Against Drunk Driving (MADD), are trying to do something about it.

Armed with a video camera, 65 middle school students set out to create awareness about the dangers of alcohol and driving. Teams created 15-30 second videos. They were screened and judged at a MADD Film Festival at RMS on May 17.

Local MADD coordinator Chris Weatherford was instrumental in making the film fest a reality. She decided it would be a good com-

munity project after speaking with MADD state director Richard Burrell.

"We didn't really give them any criteria other than saying the films should be against drinking and driving," she said. "Because this is a pilot project, all of the information and films will be sent to the national office, who are strongly considering expanding it nationally in conjunction with the poster essay contest."

Team members Jayme Paxton and Brynn Hatcher took first place in the festival with their video of a heartbeat on a monitor, a car accident followed by a flatline on the monitor, and a policeman telling a heartbroken family about a death.

"Please don't make me knock on your parent's door and tell them something like this," the officer says in the film.

Second place was awarded to Micah Ensor and Doug Siddens for

their music video style production. Their film showed cars crashing and families disappearing.

Angela Kresge tied for third place with team members Brook Lewicki and Melissa Ames. Lewicki and Ames made a film using car accidents, the cemetery and a billboard against drunk driving. Kresge's film showed twisted car wreckage while a voice said, "If you think drinking and driving won't kill you, think again."

Efforts of the seven winners were awarded with cash prizes. First place team members received \$75 each, second place received \$50 each and the three third place winners received \$25 each.

"All the money for the cash prizes was raised by MADD locally," Weatherford said.

New Mexico has more drunk driving arrests per capita than any other state, according to the National Highway Traffic Safety Administration.

## White Sands offering teacher workshop

## Real Six Time upsets field in Futurity

Trainer Sam Sandoval won his second Ruidoso Futurity in three years when 16-1 longshot Real Six Time posted a neck victory over Winalota Cash to win the Grade I \$384,155 race.

Ridden by Tome Green and owned by Carlos Marquez of Brownfield, Texas, Real Six Time broke sharply from the nine post and battled with Winalota Cash throughout the 350-yard contest before pulling away at the wire. The time was 17.85.

"He broke real well and led pretty much all the way, but never by very much," Green said. "I

thought I saw someone on the inside getting close, but the No. 10 horse (Winalota Cash) was the one I was most concerned about," Green added.

The futurity was the biggest career victory for the 29-year-old Green who joined Nancy Summers as the only other female jockey to win the first jewel of the Quarter Horse Triple Crown.

Sandoval teamed with Summers to win the race in 1993 with Treacherously.

"He's a lot more laid back than Treacherously," said Sandoval, who shipped Real Six Time from his

Santa Fe stable a day before the big race.

It was the same strategy he used with Treacherously who won two jewels of the Triple Crown before finishing third in the All American Futurity.

Real Six Time clocked the ninth fastest qualifying time of 18.47 in the May 12 trials while beating his competition by a 3/4-length.

The gelding is the first quarter horse owned by Marquez who has been a thoroughbred owner since 1977. Marquez purchased Real Six Time for \$9,000 and pocketed the \$158,554 winner's share of the purse.

## Ronas Sound repeats in derby

Fastest qualifier Ronas Sound repeated her impressive performance in the Ruidoso Derby Trials as she led from start-to-finish in the Grade I \$74,529 final, Memorial Day. Ronas Sound beat Delightful Lark by a half-length.

The Dwayne "Sleepy" Gilbreath-trainee broke perfectly from the gate in the 400-yard dash and under constant urging by jockey Kip Didericksen held off a late charge from Delightful Lark in a time of 19.80.

The win reunited Gilbreath and Didericksen who teamed for numerous Grade I victories at Ruidoso including the 1990 All American Futurity with Refrigerator.

Didericksen retired in late 1992 because of weight problems and recently returned to the saddle in his home state of Idaho. He also won a stakes race at Los Alamitos Saturday.

"It's nice to be back," said Didericksen, who finished fourth on Strikin Dash for Gilbreath in the Ruidoso Futurity on Sunday. "My horse broke in front and after that we just waited to get to the wire."

Gilbreath won the Derby for the fourth time this decade including last year with Specially Fast. The

veteran trainer also conditions third-place finisher Ligitation and JW Champ who finished fourth.

First place was worth \$30,760 to owners James Helzer and Michael and Beth Harper.

Delightful Lark earned \$14,062 for owner Gwendolyn Eaves of Midland, Texas and trainer Chris O'dell. Casey Lambert was the rider.

Ligitation was ridden by Billy Peterson and earned \$7,206 for Mike Rutherford of Houston.

NOTE: Proud And Jivey outlasted even-money favorite Full Connection in deep stretch to post a head victory in the co-featured \$63,721 Rio Grande Kindergarten Futurity, Monday.

The 2-year-old gelding is trained by Fred Danley and owned by his wife Rita. First place was worth \$31,000. 

## Skate committee leans toward indoor facility

Local skateboarders said Tuesday they would prefer to have a proposed skateboard park indoors.

Skateboarders and Ruidoso officials held their first ad hoc committee meeting Tuesday to examine the feasibility of creating a skateboard park.

The committee was formed after several downtown merchants complained to the Ruidoso Village Council that skateboarders intimidated pedestrians and damaged buildings. The council rejected a merchant's request that skateboarders be banned from the downtown sidewalks, and instead created the committee to find a more agreeable site for skateboarding.

Tembey said he would prefer the park be located in a non-populated area that is "out there."

An indoor park was what the committee was leaning toward at the end of the meeting. They decided to look at potential costs, and ways to support the park with concessions and fees.

The committee will hold its second public meeting at 5 p.m. Thursday, June 8 at the Ruidoso Parks and Recreation Department building near Grindstone Reservoir.

# Acrylic outduels favored Last Don B.

Acrylic refused to relinquish his race long lead to the favored Last Don B. to win the \$10,000 Guaranteed Governor's Handicap by a head Saturday at Ruidoso Downs.

Under the urging of Tome Green, Acrylic rushed to the front at the start of the 7 1/2 furlong Governor's. Last Don B. challenged the leader in the final sixteenth of a mile but was never able to pass the winner, who reached the wire in 1:33 2/5.

"He was doing everything he could to hold that horse off," said Green. "The first time I ever hit him was right near the wire. He likes to run on the lead, and I was pretty sure we could win that way."

The Governor's was the third straight win for Acrylic, who races for Patrick Petelski, the owner of a construction business in Albuquerque.

Thomas Pierce trains the winner, who was worth \$12.40, \$4.80 and \$3.60 for winning mutuels.

Heavily favored Last Don B. was making his first start at Ruidoso Downs since 1993, when he was voted Older Handicap Horse of the Year.

Jockey Manny Ortiz admitted that the 8-year-old veteran may

have been affected by the change of altitude, since he had only arrived from Phoenix earlier in the week.

"I think the thin air was his biggest problem," Ortiz said. "I was just waiting to cut him loose. When he headed him he stayed in third gear instead of shifting to fourth. The altitude never bothered him in the past, but he's getting a little older now."

Misting Rain, who made a strong late move, finished third in the Governor's under David Lidberg.

Brisco County Jr won the \$68,535 Ruidoso Futurity Consolation by a head in the co-feature on Saturday's card. Kenneth Hart rode the juvenile, who raced over the 350 yards in 18.02 to take home the \$16,761. winner's share.

DD Pass Em was a half length in front of third place Six Delights, who had claimed an objection against the winner that was not allowed by the stewards.

Topless Chick, the favorite in the 10 horse consolation field, finished a well beaten ninth.



## Capitan gifted students compete in state Supercomputing Challenge for second year

Five Capitan students in the district's gifted program competed in the New Mexico High School Supercomputing Challenge 1995. They made up one of 82 teams that completed the challenge, making them eligible to attend the two-day awards ceremony and tours of Los Alamos Laboratories April 26-27. A total of 181 teams started the competition. The Capitan project involved measurements of uneven surfaces

of items such as pine trees, said Ron Becker, head of the gifted program and team facilitator for the competition. Teacher Ed Davis handled the instructional end of the project. The students wrote a program to compute the measurements and then plugged it into the supercomputer. Their interim research was due in January and their final report in April. A research paper 15 pages in length also was submitted.

About 10% of the projects were presented to scientists, with resulting scholarships for some of the students, Becker said. The competition is free to participating schools and allows students to hook up with the giant Cray computer at Los Alamos. "Our kids did a really good job," Becker said of Rodney Sedillo, Jill Lunstford, Travis Jaquess, Meghan McGrath and Bryan Whipple.

Winners of the fifth annual competition were two students from Albuquerque Academy, who explored what would happen if an ice comet like the one that struck Jupiter last July came hurtling toward Earth. The Supercomputing Challenge was conceived in 1990 by Los Alamos Director Sig Heckler, U.S. Sen. Pete Domenici (R-N.M.) and John Rollwagen, then chairman and chief executive officer of Cray Research Inc.

## Two people spark holiday weekend fires

At least two fires were caused by people in Lincoln County during the holiday weekend. An illegal camper who left his campsite with a fire still burning Sunday was responsible for the scorching of about a fourth of an acre, according to the chief of the Bonito Volunteer Fire Department. "The site was right on the edge of the national forest, but on private land," said Chief Howard Puckett. "He was camping illegally.

It took us about 15 minutes to control and an hour to mop up." The fire was reported about 5:10 p.m. Units from the Ruidoso Fire Department and the U.S. Forest Service helped put it out. In a separate fire, flames licked at the roof of a residence on Lower Eagle Creek Monday when the owner decided to burn a pile of wood, siding and other construction debris. "He was burning trash and it got

out of control," Puckett said. "The flames came within 20 feet of the edge of his house and they were 20 feet high." It was the third fire reported near the man's home, Puckett said. "He didn't call us, but the neighbors did because they thought the whole subdivision was going up. The fly ash was way above the house and drifting into the forest," he said. The call came in about 8:14 p.m.

It took the department, with help from the forestry firefighting division, about 15 minutes to bring the flames under control, Puckett said. A brush fire also was handled by the Nogal Fire Department Saturday about 8:12 p.m. in Magado Creek Estates. No details were available. Because of the lack of rain, open fire bans are in effect everywhere in Lincoln County except private lands outside of Ruidoso.

The historic settlement of Lincoln and Lincoln County have been featured in several magazines over the last few months. A four-page article on Lincoln with sepia tone photographs of some of the lesser-known buildings in the settlement appeared in the February 1995 issue of *Men's Journal*, according to the Lincoln Hospitality Group headed by Cleis Jordan of Casa de Patrón Bed and Breakfast. The upscale Japanese publication, *Active Life Magazine - Vacation* dedicated 20 pages on New Mexico in the February issue, with five pages devoted to Lincoln. Two pages focused on the Casa de

Patrón and the Ellis Store Bed & Breakfast. *True West* magazine's April issue included a story on Lincoln County's L.G. Murphy, a player in the Lincoln County War who built the Big Store, known today as the Old Lincoln County Courthouse. "Wandering Palate," a food column in *Women of Greater Atlanta*, detailed a fall trip to New Mexico in the February edition. The column included four paragraphs on Casa de Patrón. Rounding out the busy spring season, *The New York Times* sent a photographer to Lincoln to take photos for an article that was scheduled to appear in March.

## Software on way to Capitan school district

Teachers in the Capitan school district will receive a comprehensive training course on how to effectively use software in their classrooms. The school district received software for the training through a partnership with Microsoft Corporation. The partnership allows teachers to be trained on the latest versions of Microsoft software.

Some of the titles are Encarta, a multimedia encyclopedia; Microsoft Publishers, an award-winning Windows desktop publishing program; and Bookshelf, a reference book with a thesaurus, almanac, dictionary, atlas and quotations. District-wide teacher training will be done during in-service and throughout the school year beginning in the fall.

## Capitan man helps Oklahoma City rescuers

D.B. Adams of Capitan was among the 22 volunteers from the New Mexico Critical Incident Stress Debriefing (CISD) Team who travelled to Oklahoma City May 15-19 to provide emotional support for emergency responders and their spouses, the American Red Cross and the VA Hospital. The team came in response to a formal request for assistance. CISD is a method of reducing the emotional stress experienced by emergency responders following a critical incident, such as the Oklahoma City bombing. The New Mexico CISD team is a statewide effort that has been in existence since 1988. The team is supported financially and coordinated through the Emergency Medical Services (EMS) Bureau within the Community Health Systems Division of the New Mexico Department of Health. Support was provided to law enforcement, fire service, emergency medical service and animal control personnel, as well as dispatchers.

All expenses for the New Mexico team were covered by a federal grant to the Oklahoma Critical Incident Stress Team. "I am pleased that our New Mexico team was able to assist Oklahomans in recovering from this terrible tragedy," said Department of Health Secretary J. Alex Valdez. The motto of CISD is "...to accelerate the normal recovery of normal people experiencing normal stress after abnormal events." Mental health professionals, clergy and peer responders are trained to conduct stress debriefings for emergency responders. These debriefings have been shown to reduce the severity and longevity of the unique kind of emotional stress experienced by emergency responders. Over the past seven years, the New Mexico CISD Team has averaged about 50 formal debriefings a year and provides numerous prevention-oriented educational sessions on an ongoing basis.

### Start small with skateboarding park


Is skateboarding a sport that's here to stay, or is it a fad that will fade alongside Hula Hoops?

The sport has seen high and low points around the country, including about 15 years ago in Ruidoso. Long-time locals recall when a man built an elaborate skateboard park on Eagle Drive when skateboarding was experiencing a boom here, but by the time it was completed, it never opened because the demand was gone.

The demand is certainly here right now, so village officials are trying to create a skateboard park where boarders can gather, to keep them out of the downtown area.

A committee was formed to talk about ideas. At the first committee meeting, there was support for an indoor skateboard park.

We tend to support something less elaborate to begin with — maybe some ramps on public property — for two reasons. One, teens can be fickle, and you never know whether they'll take to a specific site or set-up until it's there (just ask people in the many communities that built teen centers that few teens use). And two, it's hard to predict how long skateboarding will be a popular activity.
