## LOST CHILD.

A Little Three Years Old Girl  
Lost in the Capitanas.

Found After Remaining in The  
Wilds More Than Sixty  
Hours, Well and Un-  
harmmed.

This article appeared in last week's issue, but after the paper was printed there were so many calls for extra copies the supply was soon exhausted, consequently, we are reproducing it this week. Parties wanting extra can have them of this week's issue.

The most exciting occurrence the people of this part of Lincoln county have had for a long time took place this week. The two little three years old twin girls, Laura and Permelia, of Mr. and Mrs. Earl Hedgecoxe strayed away from the Hedgecoxe ranch headquarters where the family is living, and which is situated about seven miles below Encino, near the foot of the Capitan Mountain. It was early in the day Tuesday when the little girls were missed from the yard where they had been playing, and could not be found about the premises. The alarm was given that the children were lost and the nearest neighbors soon joined in the search for them. After about three hours hunt little Permelia was found out on the mountain side, but she was unable to give any account of her little sister. The news was circulated as rapidly as possible and people from all the surrounding country gather in and joined the searching party, and hunt was kept up all night Wednesday morning people commenced gathering in from all parts of the country. They came from Roswell and all the way up to Carrizozo. Captain turned out in force, including its business men and the students in the school, and a reinforcement of many hundred people were soon in the hunt. During the day at different places flowers were found on the mountain side which had been plucked and dropped, and small pieces of clothing were also found, but these were all the traces that could be discovered where the child had been. The search was diligently kept up through Wednesday night and all day Thursday. Just as it was beginning to get dark Thursday evening, while Seth Smith and his brother William of Cañitan, and a young man named Roy Vickers, were passing near where the road crosses the irrigation ditch running down to the Block Ranch, the child came out of a cluster of bushes and ran to them. Most its clothing had been torn off, and it had a good many thorn scratches on its arms and body, otherwise it was unharmed. It had been out nearly three full days and two nights and of course had suffered a great deal from cold, fear and hunger, and its escape from so many dangers seems miraculous. In its wanderings the child had evidently traveled many miles, and had gotten back within two miles of home when found. As soon as it was found signal guns were fired, and the hundreds of searchers came flocking in, but in great suspense as to whether the child was dead or alive, and when it was known that it was safe and well there was great rejoicing. The agonized parents were relieved, and the great crowd of people who had been searching for the child manifested much joy and satisfaction at the fortunate sequel of the affair. Among those who took a leading part in the search were Messrs. Fred Flintston and Hunt Hobbs to whom was assigned the work of organizing the great search party and keeping the work going with systematic order, and for their efficiency and untiring energy shown in the performance of this duty we have heard many favorable comments expressed.

### Members of Supreme Court on Record for Prohibition

The entire supreme court of New Mexico has declared flatly for the adoption of the state-wide prohibition amendment to be voted on November next. Recently, the New Mexico Anti-Saloon League addressed a letter of censure to each of the justices of the supreme court asking for an expression of their views on the proposed state-wide proposal. "The decent scope of the state will undoubtedly eliminate" was what Chief Justice Hanna declared would happen to the saloon.

Justice Roberts declared that he was for prohibition because "Fully 80 per cent of the crimes committed in this state are directly attributable to strong drink," while Justice Parker argued that "The people of the state, as a whole, will be better off without it than with it."

The following is the text of Chief Justice Hanna's letter:

Supreme Court of New Mexico  
Santa Fe, New Mexico  
R. E. Farley, Esq., Supt.,  
Albuquerque, N. M.

Dear Mr. Farley: I do not believe the people of New Mexico need an argument in support of prohibition. They must know that the saloon has been the greatest factor for evil in this state with which we had to contend. Much of our crime is traceable to the saloon, which in most without exception is a notorious law breaker and a master of criminals. The decent people of this state will undoubtedly vote for it.

Dear Sir: In reply to your request for a short expression of my proposed constitutional amendment on prohibition, will suggest the following:

"I am for prohibition, the cause of temperance on the one hand has convinced me that fully 80 per cent of the crimes committed in this state are directly attributable to strong drink." Yours truly,

Justice Roberts also admires the chief justice's resolve to the cause of temperance, occurring four days apart. He wrote:

Dear Sir: In reply to you, for the last I will say that in favor of state-wide prohibition and its use is my reason for voting. And I believe that temperance does not benefit any one except myself. The people of the state, as a whole, will be better off without it than with it.

The judges of the supreme court have sent letters to every county recorder or clerk within the state, and they unanimously agree that a large part of the criminal business that comes to their dockets is caused by bad traffic in intoxicating liquors.

### Wilson Asks for Liberty Bonds.

Washington, Oct. 15.—The administration appealed to Americans in a presidential proclamation published today, to make the second Liberty Loan even a greater success than the first, which was over-subscribed more than 50 per cent. The president's proclamation sets aside October 24 as Liberty day, and asks that patriotic celebrations be held everywhere in the interest of the loan. A half holiday is to be granted employees of the federal government, except those whose service cannot be dispensed with, to participate in the celebration.

"Let the result be so impressive and emphatic," the president urges, "that it will echo throughout the empire of our enemy as an index of what America intends to do to bring this war to a victorious conclusion."

The wage earners of the country are urged in an appeal issued by the Secretary of Labor Wilson to do their part in making the loan a success.

#### A Country Church

More so than any other institution the country church stands for charity and humanity. It is a symbol of righteousness and content, and around it occurs the scenes of laughter and joyousness, sorrow and despair.

Her meeting therefore was a mere act of charity. The deceased had been destitute and survivor was powerless.

She had made an effort to put on manners, or her son. A black ribbon of some kind tied black handkerchiefs and one or more such knots attempt to express by outward signs the grief that was within her heart.

### WOODS THAT ARE DURABLE

Above All, the Cypress Is Coming Into General Use for Purposes of Interior Decoration.

Wood, its uses and, above all, its prices, are matters of moment to everyone who contemplates building, remodeling or adding to a house.

There are some southern pines that are comparatively reasonable and which give good results. Houses built of them in Virginia and the Carolinas attest to their durability. It is suitable for interior finish, as it has a variety of grain and takes on a good finish, whether in soft stain or hard stained paint.

Cypress is better used for rough purposes. The great swamps of the South are yielding up their forests and the number is finding its way into the northern markets. This is not an strong wood as some others, but it has good lasting qualities and is equally good for exterior and interior finish. It is very satisfactory finished in its natural color.

A wood that is finding much favor for interior finish is the red gum, also from the South. It may be had highly figured or plain, quarter-sawn or plain-sawn, and it takes a very fine finish. The red gum is finished in its natural tones or stained to imitate mahogany and sometimes brown walnut.




