## To The Public.

To the Editor of the Capitan Mountaineer

By request of some of our citizens that the public may know the true condition with reference to Smallpox and Diphtheria in Carrizozo and vicinity I make the following statement:

We have had, perhaps, during the past three months, twelve or fifteen cases of Smallpox, confined exclusively to the Mexican population and a number of these became infected in other localities—developing the disease after their arrival here. It has never been epidemic, or even alarming to those of us whose duty it is to guard it, and it has never been deemed necessary to close our schools, for practically every scholar is immune from former or recent vaccination (thanks to the intelligence and common sense of our Principal and those associated with him) and at the present writing there is not a single new case of Smallpox in town, unless "hit out" on us. The last quarantine having been lifted some days ago. The same can be said of Diphtheria. We have had a number of sporadic (scattered) cases during the summer and fall, some coming from Three Rivers and other localities for medical aid, but this too has now disappeared and not a single red flag can be seen in town. I do not for a moment believe your informant misrepresented the matter intentionally, for he or she may have assumed it to be true from public rumor, which of course is always exaggerated, misleading and wholly unreliable, and if those communicating such information would only confer with the authorities before sending it, they might save themselves the after embarrassment, to say nothing of the injustice and often financial injury done the town and community in which they reside.

## Dr. Paden's Statement.

A statement from Dr. Paden, health officer at Carrizozo, explaining the condition as regards smallpox and diphtheria in that town will be found in this paper. Dr. Paden says there have been twelve or fifteen cases of smallpox there during the past two or three months, but that the quarantine has been lifted, and he knows of no cases at the present time. Although there have been cases diphtheria, but there are at this writing. The Mountaineer's Carrizozo correspondent has been criticized for stating there was smallpox and diphtheria in Carrizozo. When the statement was published there was evidently some cases of smallpox there; this is corroborated by the health officers statement. If injury has been done Carrizozo we greatly regret it, but at the same time we fail to see where the correspondent intentional misrepresented the situation. The correspondent said it was reported there were about forty cases in and about Carrizozo, but that report was not official, and as we had instructed the writer to furnish the local and that item was sent in and published. We ask our readers to carefully read Dr. Paden's statement as it sets forth the situation as it now exists.

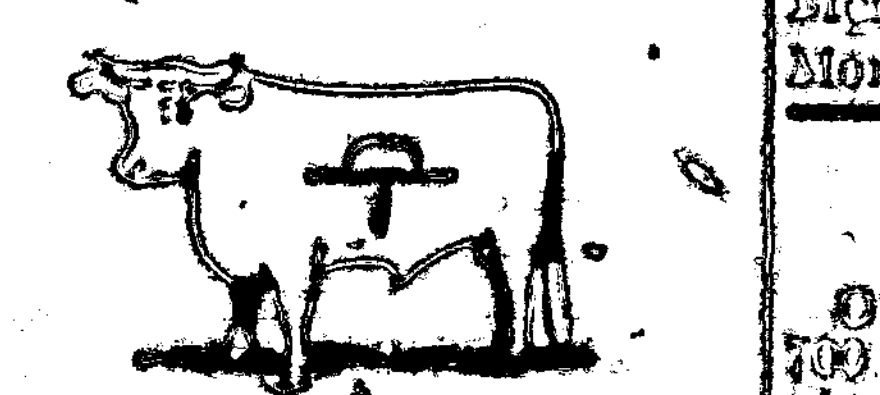

**YELLOW PERIL?**

(Continued Excerpt)

The author of that incomparable imaginative story, "The White Man's Burden," might be suspected by some readers of permitting his creative faculties to color his consideration of practical problems. But we quite agree with him when he asserts that the white races are in danger of the artificial keeping-down the birth rate. This suicidal practice is all the more ominous being from the war, disease and natural causes. Sir Elder Haggard insists that this practice is widespread in every western nation, except, perhaps, Germany and Russia. He alleges that unless "a startling change occurs the eastern races with the next two centuries will be submerged beneath a great new influx from the teeming myriads of the east."

It has not been long since another eminent authority declared "the day is not far distant when yellow men will be seen dragging white women by the hair along the streets of New, London and Paris."

Perhaps many readers will smile tolerantly when they consider these forecasts of war to the proud and virile pale races of the world. But to great a student of racial problems as Mr. Roosevelt did not regard them lightly.

A number of remedies are proposed to meet this unfortunate situation. "No spiritually inclined believe they appeal to the consciences of civilized peoples should serve to correct the evil. Others would abdicate motherhood. Still others would empower the state to stamp out disease which seriously affect the race, and as a desperate resort authorize the state to bring up all children, even holding out a hand to those not born in wedlock."

Whether we regard this matter fancifully or seriously, the fact remains that any keeping down of the birth rate in Europe and America, in the face of the potential preservative possibilities of the east, must be regarded as foolish and characterized as Mr. Roosevelt characterized it, "race suicide."

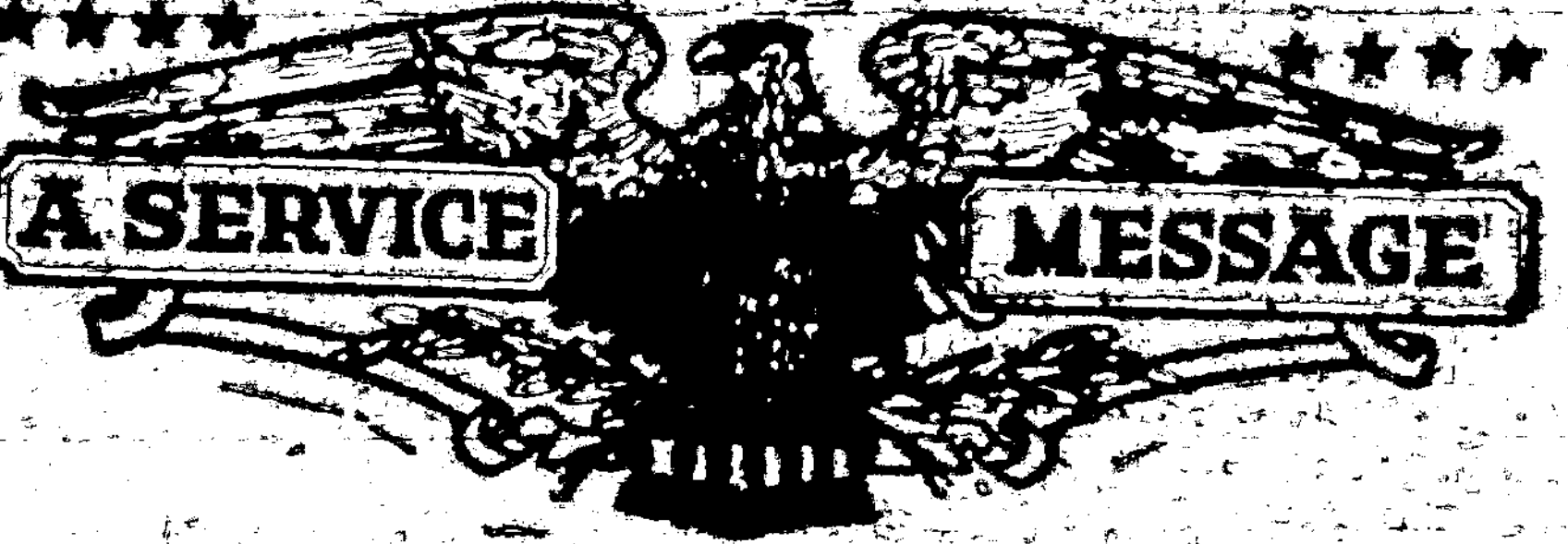

### Milk Stew With Vegetables.

1 quart milk, whole or skim.  
1 cup raw potatoes, cut in small pieces.

A few leaves lettuce, spinach, or other greens cut into small pieces or chopped.

A small piece of onion.  
2 level tablespoons butter or bacon fat.

Salt.  
Boil the potato till soft and drain. Cook the other vegetables in so little water that they do not need to be drained. Add to the milk. Heat, add the fat, and season with salt.

Almost any vegetable can be used for flavoring milk stews. Or a little fish or chopped dried beef may be used. In the case of very little children care should be taken not to serve any tough

foods like large pieces of dried beef unless the mother has time to watch and see that they are well chewed.—News Letter.

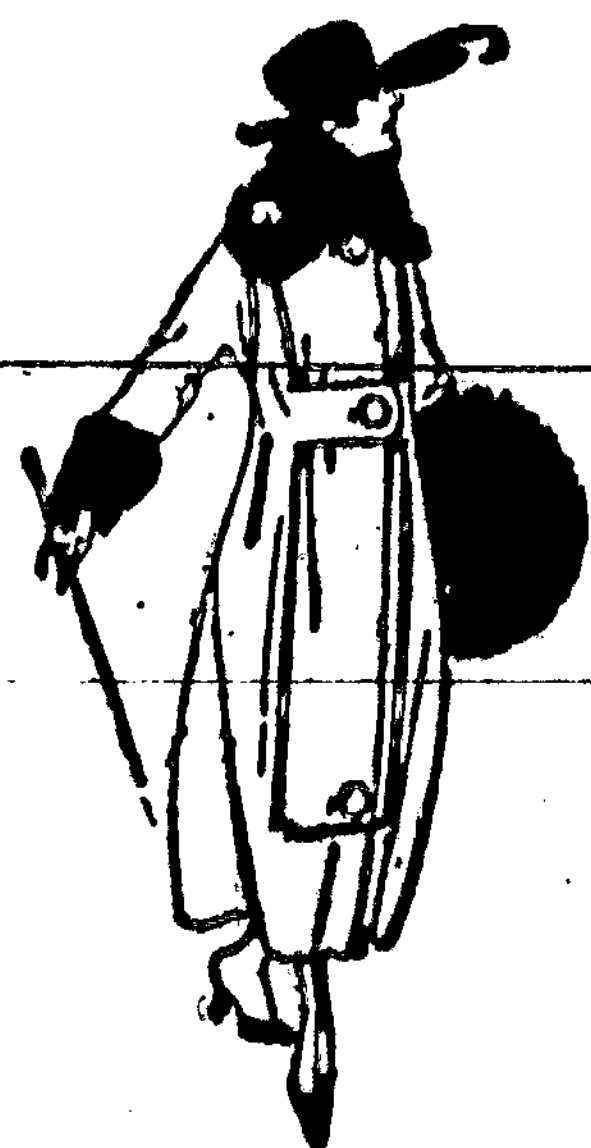
